OCMBC Executive Director Report

Fd Willms

It is a privilege and honour to share with you some of the things I see God doing in our midst. Serving a Board of Directors that is passionate about the health and missional focus of the Ontario Conference has been inspiring. 2016 was a full but very rich year. We were blessed by Gordon & Gail MacDonald at our Pastor/Leaders Day and Convention. We launched Leaders Collective. We hosted Gathering 2016 (our national bi-annual AGM). We held church planting discussions regionally in the fall. I attended many of our churches, and connected with nearly all of our pastors.

The largest focal point of our Board this year has been on aligning our efforts with the CCMBC Ministry Model. We truly believe that we are stronger and more effective as we serve in tandem with leaders across Canada. To that end we are intentionally living into this relationship. To show some of how this works, I will break my report into the four key ministry areas that we share.



eveloping Leaders

- We launched Leaders Collective with some fanfare at last year's convention, recognizing that raising up the next generation of leaders is a focus we need to own together. The pilot year taught us a great deal. The mentoring and inner city exposure opportunities were key highlights for participants. Robyn Serez was appointed to build this initiative and we look forward to LC 2.0 beginning this fall.
- Although we have had two Study Conferences on Human Sexuality as a national body, practical pastoral steps moving forward are proving challenging for many of our leaders. On Friday before convention we will hold a candid conversation with our Pastors from across Ontario. Bruxy Cavey from the Meeting House will be with us as our key resource person.
- A new partnership between MB Seminary and Tyndale Seminary has now become a reality in Ontario, which is very exciting. The first course "Anabaptist Spirituality for today's Church" will be offered in Niagara, June 12-16, taught by Andrew Dyck, at Vineland Southridge. This investment nationally into our province is much appreciated.

Multiplying Churches

- We continue our partnership with C2C in our efforts to plant new churches and to see healthy churches multiply. I work alongside Trevor Seath (Regional Director) in these efforts. C2C will provide a more comprehensive report.
- One development has been the interest of a few church plants who are seeking Denominational affiliation. At this year's PCO several such leaders participated. I look forward to what God will do with these connections.
- This year during summer and the lead up to Christmas I witnessed some amazing outreach efforts across our province. We have churches that are effectively and passionately sharing the love of Jesus.
- The Rugged Tree ministry has seen significant growth in their efforts among First Nation People in the Parry Sound area.



Building Sommunity

- A highlight this year has been a renewed 'leaning in' of several of our churches.
 After several years of isolation or autonomy, these churches are reconnecting.
 In partnership with L2L, I've been witnessing healthy reengagement.
- We hosted the Pastor Credentialing Orientation on February 21-23, 2017. We are thrilled that 40+ leaders participated, making this a historic event in Ontario. We believe this will enhance our partnerships. We are also taking the entire Credentialing process far more seriously.
- Three churches called new lead pastors this year: St. Ann's, Meadow Brook, and Grace MB. Multiple others found additional staff personnel. The task of credentialing all these leaders is a huge responsibility of the Faith & Life Team.
- I worked alongside L2L in three different church contexts this year: Orchard Park, Fairview, and Kitchener MB. Each situation has seen some very positive momentum.
- We are now able to offer our churches more support with Plan to Protect.
 Check out the resources available here at convention.
- We continue discussions with Bethesda about the most helpful ways to empower them, and release them from the present limitations that our present by-laws create.

Resourcing Ministry

- This year is the second consecutive year that we have exceeded our Church Budget line. This speaks to our growing alignment and partnerships.
- The Autism Centre at Bethesda was opened this year. This partnership was partially made possible by the Stewardship Fund of CCMBC.
- Behta Darya is completing a major renovation of their new worship centre. We look forward to a grand opening celebration in late Spring.
- In 2017 several churches are launching large building projects. In each case, it speaks to their health and vitality. Praise God for what he is doing.



On a personal level, I would like to thank the many who pray regularly for myself and my wife Karin. Last spring, I had a 'dark night of the soul' experience related to my health. I give God all the glory that I have experienced significant healing. I'd like to publicly thank my Board for their gracious support during those challenging months.

This year has seen significant transition of leaders. On a positive note the addition of my Ministry Assistant, Kristi Lee, has greatly enhanced our capacity to live out the Ministry Model. I sense we are gaining traction towards becoming a healthier more robust organization. Adding Christine Hamm as our book keeper has also been a positive step. At the same time, we've experienced loss. The transition of Willy Reimer CCMBC Executive Director has been difficult. His transition will be felt in Ontario as he was appreciated and loved by us all. God remains in control of these matters, and so with anticipation we look forward to forging a strong connection with Steve Berg the new Interim Executive Director for CCMBC. Steve's experience in managing change, his leadership gifting, and his heart for Jesus and His Church will be a gift to us in this season. We are committed to our national vision to see Canada transformed by the good news of Jesus Christ.

I offer these thoughts with gratitude and humility. May God continue to build his church.

For 2017, we are proposing that Karen West (as my designate on the CCMBC board) step in to the role of Vice-Chair on our Board, and that Shelley move to a member-at-large role while continuing to serve as our Treasurer. Given Karen's role on our National Board, we felt it was best for our Board that she step in to this role for 2017 (details regarding other remaining board roles for 2017 are available through the Nominating Committee report).

Within the 2016 fiscal year, the Board met in person for a full day in April, June, August, November and January, with additional teleconference meetings held as necessary in between. We have been working through many processes and initiatives, with the key ones being:

- intentional partnership with our Canadian MB Conference around a common vision and commitment to the ministry model
- further implementation of our vision and mission in Ontario
- overseeing and partnering in the work of our Executive Director, Ed Willms as he works alongside our churches and ministries (see Ed's report)
- leadership gatherings through the Pastor/Leaders' Retreat, and the Fall Regional Gatherings with C2C
- partnering with C2C to plant healthy churches in Ontario, as well as to discern how to further help position MB churches for multiplication
- various Board Committees: Faith and Life Team, C2C Team, Finance, Executive Team, and Governance Committee
- supporting the "Leaders Collective" a program that exists to equip young adults in Ontario for ministry leadership
- supporting the agencies/ministries that are connected to the Ontario Conference

Treasurer's Report

for year ending December 31, 2016

The Ontario Conference of Mennonite Brethren Churches continued to bring careful stewardship to the resources provided primarily by member churches. We are pleased to report continued growth in the various contribution sources. This is particularly profound as, for roughly half of the churches, we saw steps of faith to provide for the Conference even though these churches were challenged to meet the needs within their local ministry.

This kind of faith and vision for ministry beyond local congregations allowed the Conference to continue an affirmed mission that includes facilitating collaboration, providing accountability and encouraging blessing amongst our churches and agencies.

Our stewardship included the very visible receiving and reporting of revenues and the allocation of those revenues across various expenditures according to the budget delegates approved at Convention. This year, our expenses exceeded our revenues as expected, and as planned, we drew on the fund balances available to us to balance our books. We are pleased to report that our need to do was roughly \$7,000 less than we had anticipated:

Our stewardship also included strengthening the not so visible means by which we manage and report. To that end, in 2016 we began to define more clearly the financial systems and controls we use. This included developing a treasurer's checklist that will help to ensure various financial administrative responsibilities are attended to in a timely and consistent manner. It also included crafting a clear policy around Director's expenses and reimbursements.

Additionally, we contracted Christine Hamm as our bookkeeper, initially short-term and then permanently, given her expertise. We deeply appreciate her standard of excellence as she worked hard on refining our bookkeeping practices, while working closely with our auditor, our staff and the Finance Committee of the Board to ensure clarity, accuracy and transparency in our reporting.

We look forward in 2017 to celebrating with our churches continued growth in our capacity as a Conference to fulfill our mission. We seek to grow in a shared vision generously resourced by churches and individuals with faith that God is using us together to meet the local and provincial ministry opportunities before us.



Leaders Collective

September 2016 saw the graduation of the first cohort of Leaders Collective. At a Debrief Retreat held in Niagara, stories and experiences were shared, final encouragements and affirmations expressed, and a commissioning blessing extended over the group. These young leaders are continuing to seek out opportunities to grow and flex their leadership as the journey continues.

It has been a privilege to serve alongside our churches in providing the Leaders Collective experience for young leaders who are currently serving within our Conference. The following is a summary of the vision and also the coming activities that the next cohort, starting in September of 2017. Please join us by praying for this ministry track as well as considering who from within your church could benefit from such a "value-added" experience.

Robyn Serez, Director of Leaders Collective

Leaders Collective is a mentorship and development track for young adults engaged in ministry within MB churches in Ontario. It has come from a deep desire to invest in a generation of discipled young leaders. Out of a heart for unity and collaboration among churches and partnering organizations, Ed Willms (Ontario Conference of MB Churches), Philip Serez (MB Mission), Trevor Seath (C2C), and Ed Heinrichs (Camp Crossroads) have covenanted together to offer this leadership development track. Robyn Serez from MB Mission is the Director of the program.

It provides "value-added" opportunities for young leaders to engage in a mentoring relationship from within their local church; interaction with others in their demographic; and a broadening of their skills and understanding of leadership through dialogue, retreats, readings, exposure to seasoned leaders, and serving opportunities both regionally and globally. All of this takes place while still allowing the participants to remain in their local church context. It provides churches with an opportunity to remain an integral part of the development of our young people while

still providing experiences and resources on a larger scale, looking to give exposure to the magnitude of ministry in the Kingdom of God.

The program is 12 months.

Multiplying Churches

Ask for Rain

C2C network asked God for rain and to transform spiritual deserts into streams of Living Water. We asked God to rain down his grace through the planting of new congregations who would make new disciples and send new leaders. The desert is budding with new life as the rains of God's Spirit saturate Canada's parched soil.

C2C network exists to glorify God and make disciples by planting and multiplying gospel-centred churches and enabling new missional opportunities. The goal for C2C is that more people come to faith in Jesus Christ. We come alongside individuals, churches and provincial regions to enable church planting wherever they have a vision to expand the gospel's impact.

God miraculously rained down the finances needed

to fund church planters and support church planting all across Canada. He also rained down a fresh vision for more labourers in the Lord's harvest.

Building Community

"We want to be a BFL that's listening," says David Miller. In 2016, the Board of Faith and Life welcomed Miller as chair and Paul Loewen as vice chair.

The Board of Faith and Life is called to watch over the spiritual life of Canadian MB churches and give leadership to the teaching of our confession of faith as we "multiply Christ-centred churches to see Canada transformed by the good news of Christ."

Publications produced or initiated in 2016 include a statement on ordination, a Chinese translation of the MB Confession of Faith commentary and pastoral application, and a pamphlet on creation and faith (set to be published in March 2017). In 2017 we can expect to see a revised Canadian edition of Family Matters (required reading for all pastors in the credentialing process), as well as a pamphlet

on the sanctity of life by Pierre Gilbert, focusing on theological and worldview issues that are at stake when thinking about abortion.

The BFL is involved in planning Equip Study Conference 2017 to be held Nov. 1–3 in Abbotsford, B.C., which focuses on the theme of Transforming Discipleship.

Robyn Serez (MAL), Christine Longhurst (Manitoba representative), Elton DaSilva (MBCM executive director), Phil Gunther (SKMB director of ministry) and Brent Hudson (Atlantic Canada) also joined as new members in 2016.

"It's a great group of people," says Miller. "we have a sense of moving ahead together, asking 'how can we serve more effectively?'"

Resourcing Ministry

CCMBC financial services resource ministry by offering financial and administrative services and tools to churches and organizations to help them achieve their mission. The mark of our success is when Mennonite Brethren churches are partner ministries have access to services and resources to help them achieve their mission.

Budget update

The following comments are based on the internal CCMBC financial reports as of December 31, 2016. The analysis is a comparison between the actual year to date results and the annual budget that was approved at the annual general meeting in October 2015 and an analysis of the CCMBC financial position at December 31, 2016. This information has not been audited and has not been consolidated with the for-profit corporations.

More specific details will become available once we receive audited statements.

 Church contributions, donations and grants as well as interest income came in under the 2016 budgeted amount.

- Ministry expenditures as well as stewardship management expenses were below 2016 budget amounts.
- The net result is an operating surplus which will be added to the accumulating operating reserve.
- In response to the budget amendment passed at Gathering 2016, stewardship surplus (capital gains, recovery of credit losses and 10% of the surplus from stewardship management) was transferred to the investment reserve fund.

CCMBC Moderator's Report

Imagine being a family of MB churches that is absolutely committed to being on one mission together - locally, nationally, and globally. If you google the word "commission" you find it is an instruction, command, or duty given to a group of people and it comes with the required power and authority to carry it out. This is what Jesus gave the church - it's known as the "Great Commission" (Matt 28:16-20). It came with some pain and conflict (vs 16 - now eleven instead of twelve). It came amidst ongoing doubts and fear (vs. 17). But Jesus gave clear authority and power in His Name and through the Holy Spirit to carry it out - a discipleship revolution that would transform individuals and families through the work of the church. That is a mission that motivates me and all of us who lead in the Canadian Conference of Mennonite Brethren Churches! What a joy to work with you in our calling (our great co-mission) that has eternal significance and power in the heavenly realms.

It is becoming increasingly clear that this vision of one mission is possible as we:

- Help to multiply leaders and disciple-making churches in local communities
- Strengthen and support vibrant provincial bodies to help our churches
- Build a lean national structure that provides connection and meaning, and
- Learn from and engage with our global family

At the recent (Jan 26-28, 2017) executive board (EB) meetings we made a number of decisions to continue moving us forward in this direction.

We received a thorough report outlining the extensive consultation that has occurred over the past two years, along with a subsequent recommendation from the C2C/MBM task force. From the prayerful discernment of this report, and the ongoing evidence of strong support, the EB unanimously approved a motion to be discussed further at our provincial conventions, that will be brought for a vote at a

Special General Meeting just prior to Equip 2017, in Abbotsford this upcoming November. The EB recommendation is that MB Mission assume responsibility for the mission and ministry of C2C network. We are excited for how these two unique ministries together will bring God's mission to the forefront of the local church – locally, nationally and globally – building on the strengths of each. We have encouraged them to collaborate even more as we move in this direction.

Another area where we want to build one mission is through increased provincial and national collaboration. There will be numerous meetings as part of (and surrounding) Multiply 2017 in Vancouver. We plan to work closely with provincial leaders as we listen and talk to each other and collaborate on ministry together.

The efforts to reach out and dialogue with members across Canada have included communication about our financial situation. We provided additional information last October and followed up with a moderated conference call in December 2016. We will continue to search for the best ways to keep the communication flowing. Steve Berg and/or myself (along with other EB members and staff) will be at each of the provincial conventions to continue the two-way dialogue.

Our financial situation remains challenging, but we are encouraged by the preliminary year end results for 2016. These results, along with the adjustments to the 2017 budget, reflect alignment of the leadership team / board with the intent and spirit of the 2016 AGM amended budget for cost savings and for rebuilding surpluses. In regards to Stewardship / Legacy Funds, Howie Wall and Jim Davidson brought a full update and explanation to the board about the path that brought the conference to the current place, as well as the steps in place for moving us forward in both our registered and non-registered funds. These include applications to each of the regulatory agencies and authorities in which we operate. Additional plans and decisions will come out of our May meetings.

The path to one mission took us through a challenging and emotional time of transitions over the last months. We continue to strive to prayerfully understand and address some of the past, current, and future conference issues. Ron Toews has done an incredible job at an unsustainable pace in the past two months as our short-term interim executive director (ED) and we are extremely grateful to him. He is returning to his previous role as director of L2L. Steve Berg has been affirmed as our longer term (but still interim) ED beginning February 1st, to build on the work and direction that Willy has led us in. We are excited for the gifts and passion that Steve will bring to this transitional role. We are also so thankful for the many gifted and passionate staff that serve in our conference, both in upfront ministries and behind the scenes in various support roles.

We continue to need and pursue a discipleship revolution of healthy, multiplying, Christ-centered

churches to see Canada transformed by the good news of Jesus Christ. This is our prayer and our work. May God give us faith, courage and wisdom for our mission together!

I conclude with the words of Paul in Ephesians 3:20-21; "Now to him who is able to do immeasurably more than all we ask or imagine, according to his power that is at work within us, to him be glory in the church and in Christ Jesus throughout all generations, for ever and ever! Amen."

C2C Network

Looking back on 2016, our hearts are full of thanks and praise to God! It's a privilege to come alongside church planters as they're empowered by God's Spirit to lead communities who live out the gospel in word and deed. Our Father is also drawing His Church into deeper unity for Jesus' sake. The spirit of generosity, collaboration, and genuine love among leaders across denominational lines continues to grow.

God is working

We celebrate that four church plants in Ontario (including The Journey and Behta Darya Community Church) were ready to operate without a subsidy from C2C in 2017. New church planters also joined us so that we're currently working with 13 church plants representing 10 denominational families. Two of those church plants are Mennonite Brethren (FreeChurch and Rugged Tree). It's been exciting to see interest in joining the MB family

among church planters in Ontario who do not have a denominational family. We are currently in the early stages of discernment with five church planters who are praying about planting with the MB in Ontario.

Nothing is closer to the heart of our mission than seeing new believers confess Jesus as Lord through baptism. We thank God that C2C church plants celebrated 702 baptisms across Canada in 2016. It's a special joy to see 245 baptized in Quebec. There were 75 baptisms in church plants that C2C serves in Ontario. We thank God for every person that He has saved and plead for more! Your Kingdom come Lord!

We have the privilege of facilitating a two-year Church Planter Incubator training program in 9 Canadian cities. About 80 planters and apprentices participated nationally in this training in 2016. Currently 16 are enrolled in Ontario with a new cohort of 12 in Toronto/Hamilton and a group of 4 in their second year in Ottawa.

Serving the Mennonite Brethren

Our relationship with Mennonite Brethren churches in Ontario is foundational for all that C2C does. As we work with a variety of denominations to plant churches, we are decidedly "pro denomination". Believing that family is important, we want to serve our MB family as best we can. As C2C Network's director in Ontario, I have been able to serve our family by:

- Preaching at FreeChurch, Orchard Park, The Gathering, and Fairview MB.
- Participating in the MB Leaders Collective (LC) weekend at Camp Crossroads in January and organizing the LC weekend in Toronto in April.
- Training on The Core of the Gospel for AWAKE Niagara and AWAKE Kitchener Waterloo.
- Assisting with Experience Toronto in connection with the CCMBC National Gathering in Toronto.
- Meeting with MB pastors for 4 special meetings of prayer and discussion towards catalyzing church planting among the MB in Ontario.
- Engaging with Niagara pastors regarding their emerging planting vision for the Merritton community of St. Catharines

- Discerning with church planters & plants regarding joining the MB family.
- Serving on the board of The Jesus Network

Looking forward

As we see God working around us, we long for a greater work of His Spirit in our province and nation! Please join us in praying! Set an alarm for 10:02 each morning and join us in following Jesus' command from Luke 10:02: "Pray earnestly to the Lord of the harvest to send out labourers into his harvest." In recent days eight couples have reached out to C2C as they have sensed God's call to plant! It is amazing to see how God is answering our prayers.

We are excited to have the opportunity not only to work with church planters but also to equip both new and established churches for mission and multiplication. We just had a tremendous gathering of leaders from across Canada for **Multiply 2017** in Vancouver. Along with insightful training from pastors who are actually walking out the journey of multiplication, we prayed together and dreamed about what might happen if the 11,000 evangelical churches in Canada were captured by Jesus' vision for mission, multiplication, radical generosity, and intentional discipleship. It was an amazing time!

In the coming months, we're bringing more excellent equipping opportunities for churches in Ontario. We're excited to partner with International Justice Mission (IJM) to host **Jesus + Justice** April 25 in Toronto and April 26 in Hamilton. Mark Wollenberg from IJM (who has planted 4 churches) will lead us in a practical exploration of how Jesus is calling us to remember the vulnerable and marginalized in our church's mission.

And then on May 5 & 6 we're excited to have Jeff Vanderstelt with us in Ontario for **Saturate** in Toronto. Jeff wants to help equip everyone in your church to apply the gospel in everyday life. The training will help us to think and live more as missionaries in the everyday.



- MB Seminary offers financial aid covering up to 32% of tuition on both Langley and Winnipeg campuses
- Up to 2/3 of the Master of Divinity and Master of Arts in Christian Studies in Langley can be completed off campus many courses are made available through modular classes, online classes, and live-streaming options from both Winnipeg and Langley
- MB Seminary subsidizes online courses at \$400 for Mennonite Brethren students
- L2L makes the Leadership Training Matching Grant available to Mennonite Brethren students studying at MB Seminary, covering up to 50% of tuition in partnership with the local church

Ontario Delegates,

Recently, we have been teaching in all our programs how the Gospel is peace, adoption, reconciliation, truth, salvation, and victory over evil. Each of us are learning how to experience these and share them with greater freedom. AWAKE, SOAR, ACTION, TREK and other opportunities in global mission are designed to multiply healthy disciples and develop missional leaders. As we embrace this goal together we will see our congregations grow in health and effectiveness in mission.

This is what motivates our local team here in Ontario, and our service throughout Eastern Canada. We work tirelessly to develop effective methods with you in equipping the whole church for mission. Our AVOCAT prayer training weekends have led many of our churches to engage in mission personally through intercessory prayer. Our EMBRACE missional retreat for young adults always features a key missional leader who is living out these values globally. Our commitment to

Ontario's Leaders Collective is of deep importance as we collaborate to release apostolic leaders into the MB church and its mission.

In recent years, I see new lines connecting Eastern Canada and the rest of the world. God's Spirit is leading us to strengthen ties with Portugal, France, Central Asia and Burundi, and continue other partnerships. Multiple churches are partnering for Kingdom advancement in these places. We are sending our own out as longterm missionaries, and supplying them with the resources, prayer, and short-term teams necessary to fulfill their mandate. This truly is from the 'river (the Great Lakes and the Saint Lawrence) to the ends of the earth' (Ps 72:8).

As we work together effectively, our congregations will be renewed and engaged in extending the mission of the Church. We will take our place alongside the global community, responding to poverty in Burundi, persecution in Central Asia, secularism in Europe and complacency in our own neighbourhoods. Our emerging leaders will cut their teeth alongside Doug Hiebert's strategy to develop church leaders in Burundi. Our business people will partner with Portugal's Bridge program to reach out to local entrepreneurs in faith and deed. We will visit in homes of Turks and Syrians grappling with conflict and geopolitical instability. We will engage in disciple-making both from sea to sea. AND the river to the ends of the earth.

God is raising up new long term workers from this region. After

two years serving North African immigrants in Europe with Team C4 Sean Fast returned to Ontario in December and is prayerfully discerning God's long-term call on his life and his next steps. In January Joanna Pharazyn from Woodstock arrived in Portugal to immerse herself in language study and join the diverse church planting team in the greater Lisbon area. We invite your prayers for Sean, Joanna and the others who are in the journey of following the call to global mission.

What would it look like for your church to partner more deeply with MB Mission?

We believe the local church's role is to lead in global mission. It's our role to equip you to engage effectively and to provide missionally healthy access to the global church. MB Mission Eastern Canada is prepared to journey with your congregation at an equipping level through the aforementioned opportunities and more. We would like to help you discern and commit to a specific global community and build multiple long term connection points with a 'sister church' through the stages of sending out workers, church planting and building capacity.

Your congregation has a role in the financial investment of disciple-making and church planting globally. We pass with honours when audited by the Canadian Government, and reviewed by the Canadian Council of Christian Charities. Our financial policies, fund delivery and tracking systems are industry leading. We are confident we can direct your global giving in a way that is Spirit-led and fiscally responsible.

What could your next steps look like with MB Mission?

- Prepare a youth team for SOAR Montreal July 2017.
- Join a vision trip to Central Asia, Portugal or Burundi in the next 12 months.
- Reserve a Sunday morning for myself, our team or a visiting missionary to teach and inspire.
- Use ACTION Ontario to develop your young adults missionally, and bridge your congregation globally.
- Invite us to visit with your church leadership or mission committee to discuss possibilities.
- Invite us to develop a local AWAKE mission event with you.
- Send a van full of young adults to the EMBRACE: God, Neighbour,
 Stranger retreat and help us build this as a province wide Young Adults
 Mission Immerse.
- Host an AVOCAT Intercessory Prayer training weekend for local churches.
- Begin the discernment process toward a long-term partnership globally.
- Prepare a multigenerational trip to your missionary with our training and debrief help.
- Increase your annual giving to MB Mission, both toward specific projects but also generally to equip our full team to fulfill its mandate better.
- Encourage TREK as an alternative to other 10-month mission options because it integrates young adults into a global network of long-term relationships and MB church planting strategies.
- Integrate our mission documentary videos into your teaching series.
 Our latest, the story of Doug and Deanna Hiebert and their journey with the Batwa people of Burundi. (mbmission.org/video/not-forgotten) (mbmission.org/video/not-forgotten)

And this is just the beginning! It is a privilege to be in team with you here in Eastern Canada. Our hope is to strengthen our relationship with you. Please let me know we can take next steps together. It can start with just a call or a coffee in your area. We look forward to it.

MB Mission Global Report

Today, mission is from everywhere to everywhere.

At a recent church planting conference in Vancouver, I was inspired by several experiences that convinced me more than ever that we need to embrace this new reality. The event was sponsored by C2C, an interdenominational church planting network birthed by the MB church. I loved the international flavour of the gathering.

I sat next to several leaders from our MB conference in Paraguay who were attending the summit to be better equipped to plant churches in Paraguay. In celebration of their first fifty years of existence, they believe God wants to double their number of churches in the next five years. They came to the summit because they know that this vision requires spiritual renewal and new strategies.

At the same event, I also met a pastor from Brazil that God has called to plant churches in Canada. Several years ago, his church in Brazil was praying for the nations. As they listened to God, they were led to pray for the least reached region of North America, which they discovered was the province of Quebec. They sensed that they were called to send their best, so they sent their pastor.

What bold mission prayers are we praying? Are we sending our best?

If our global MB family is to see greater synergy in our missional strategies, we need to work collaboratively on this one mission – local, national and global.

We need to be aware that multiplication and addition are different; they require different strategies. But both require the renewal of faith in mission. As we embrace one mission, we need to understand the key to multiplication according to Jesus: "Unless a kernel of wheat falls to the ground and dies, it remains only a single seed. But if it dies, it produces many seeds" (John 12:24).

Are we willing to die to ourselves to see God's mission accomplished?


At the same event in Vancouver, a Filipino pastor stood up and shared about how difficult it was for him to be in a room with 250 pastors. At the age of thirteen, he had been sexually abused by his youth pastor. When he disclosed the abuse, it had been covered up. In his anger against pastors, churches and God, he became a prodigal. He left the Philippines and ended up in Winnipeg. One night in a bar, the Father spoke to him and called him "home." He cried out to God in brokenness and repentance, and experienced the love and forgiveness of the Lord. Then he began calling others to join him. In the following weeks, he led dozens of friends to Christ. A house church was started, which has now grown to dozens of house churches of new believers in Winnipeg!


After hearing his story of abuse, I sensed the Lord speaking to me. I walked up to the podium and stood in the place of spiritual leaders that had hurt this young man. I asked him to forgive us for misusing that authority and grieving God. He fell to his knees and cried out as his pain was released. We wept in each other's arms and I prayed for more prodigals to come home. What happened that evening in Vancouver had an effect on what is happening now in Winnipeg and in the Philippines. The seed is multiplying worldwide!

I am encouraged that one mission – local, national, global – is increasingly shaping our vision and practice as a global family of churches. Let's continue to follow Jesus without wavering and to embrace his mission in the world today wherever he will lead us.

If you're a sports fan, you'll recognize the term "By The Numbers" as a reference to analyzing an athlete's statistics, past or present. In the Spiritual Life Centre we took a look at some, "interesting numbers" so here they are. Annually the SLC...

- sets up approximately 36,000 chairs for chapel.
- serves close to 1300 slices of pizza.
- spends 54 hours together in prayer for our students.
- sets up over 1400 feet of sound cables for teaching and music chapels.
- spends over 700 hours mentoring students.
- facilitates close to 100 hours of community through Life Groups.
- celebrates the over 50 countries that have been impacted for Christ by current Eden students and graduates.

This is a practical snapshot of our ministry to 854 students as we "lead students to learn of Christ and live for Christ." Here are some further updates from this past year!

than ever about what God is doing in our midst! On behalf of the SLC team and the Eden Advisory Board, I'd like to thank the Ontario MB Conference for their support and encouragement! Through your prayer and financial support, you partner with us in serving the Eden students for the glory of God!

Student Leadership

As we think about our ministry areas, we strive to use the term "catalyst" rather than "program" as we strive to help encourage students forward in their faith. In everything we do, we are desiring to make disciples that are leaders and there have been some tremendous moments. We are well into our second year of Epereia, a leadership initiative that is seeking to "equip students for Christ-like influence." We have students leading life groups with their peers, actively seeking to share Christ personally with unsaved friends and participating in mission trips. Recently one of our students spoke in chapel and I became emotional as I listened to this young man share God's Word in a powerful way. He spoke about the importance of reading God's Word sharing this thought: "Sometimes we are afraid to read God's Word because we believe that it will show us that God has removed Himself from us because of our sin. That is not true. It doesn't show us that God has distanced Himself from us. It shows us that we have distanced ourselves from God and He is calling us back!" (I can give you his name if you need pulpit supply!) One of last year's team members has received a calling to begin Biblical studies seeking to enter into full-time ministry! It is so exciting to see students grow as disciples of Jesus and be willing to enter into leadership roles.



Chapel

Traditionally, Eden is a school that featured a high percentage of students coming from a Christian background. In recent years, more and more students are attending who have little or no understanding of the gospel of Jesus Christ. Therefore, in our Junior Chapel (grades 9-10) we are connecting students with the scriptures, demonstrating that they are relevant to our lives. In our first year, we focus on the panorama of God's Word using a resource that uses five key words to connect the story: Eden, Exodus, Election, Empire and Exile & Return. Each illustrates sections of the Bible as we encounter God's relationship to humanity. As an SLC, we have created the New Testament equivalent using the following terms: Incarnation, Invitation, Inspired Living, Intentional Community, and Indescribable Destiny. Each of these highlights the life and teaching of Christ as outlined in the gospels and the ministry of the early church. The second year focuses on "What we believe" using the Apostles' Creed to teach students the foundational doctrines of the faith. This past year was our first attempt at these topics and it was encouraging to see students grow in their knowledge of what it means to be a disciple of Christ. Our Sr. Chapel continues to build upon this foundation as we equip them to respond to their world with a Biblical worldview.

Grade Retreats

We continue to engage grade 10-12 students through off-site retreats at Camp Crossroads, but this year featured a new adventure! We hosted our first grade 9 retreat, taking 135 students and approximately 50 volunteers to camp! It was a strategic opportunity to build relationships with new Eden students and was amazing! The positive feedback we received from students and parents was overwhelming. Please pray that these connections grow into stronger relationships with our first year students.

May God continue to bless the work of the Ontario MB Conference and the SLC!

IM (without government funds) Niagara Family Centre, a state of the art facility, designed to provide children and families dealing with autism and neurological issues facilities that aid in the effective delivery of supports. Additional space is allowing Bethesda to adequately adapt to recent Governmental requirements in the

delivery of Autism Services. In addition, Bethesda is now positioned to support additional

children. Of note, the Centre was completed ahead of schedule and approximately 7% below our budget. It is not too late for Conference members to get involved. We are continuing to solicit donations towards the Centre. Please contact Bethesda if you would like to partner with us in making a profound difference in the lives of Families.

Towards the end of 2016, we experienced significant growth within our Children's support programs. Additional Government funding for Applied Behaviour Analysis and Intensive

Behavioural Intervention spaces will allow us to assist many of the children on our existing wait list. We are pleased and thankful for the confidence and financial support provided by the Provincial Government.

The Bethesda Home Foundation Inc. Board of Directors is in the process of reviewing its organizational structure. The intent is to reorganize in order to leverage Board member skills appropriately. Currently, Board members are asked to promote organizational fundraising as well as govern operations. Discussions have continued between the Conference and Bethesda regarding a new progressive working relationship that will assist Bethesda in expanding its support base in order to improve service delivery to people with special needs.

On behalf of the Bethesda Board of Directors, I am pleased to report that all three corporations completed this past fiscal year with balanced budgets.



The conference included a Face2Face community conversation involving persons from Jewish, Muslim and Christian traditions (those who share faith roots within an ancient Abrahamic tent even as they are highly divergent), sitting with one another under a temporary canopy for conversation.

Centre for Faith and Life

CMU has launched a Centre for Faith and Life as a means of linking individuals, congregations and ecumenically diverse constituencies with the university's unique, nonformal, church engagement and resourcing initiatives. CMU has created a Centre for Ecological and Economic Resilience to bring together social enterprises committed to ecological and economic health and well-being. James Magnus-Johnston, CMU Instructor of Political Studies and Economics, is Director of the Centre.

Alongside the church, CMU remains active in responding to the Truth and Reconciliation Commission 'Calls to Action'.



- **2. Interpretative resourcing** includes offering analysis on questions of theology and history as requested by individuals, congregations, and conference ministries.



- New in 2016. Archival Development Grants, designed to support church archives in North America and outside North America. The MHSS (Saskatchewan) won the 2016 grant of \$2,000.
- New in 2016. GAMEO Stipends, designed to encourage submissions of biographies, congregational histories, and institutional histories for the online encyclopedia.

When our current residents have either moved to another level of care or passed away He has brought us new residents to keep Valleyview Manor at full capacity. He has also met the many personal needs of our seniors which allows them to maintain their independent living. Even though we've not had our own on-site support staff, over the years we have developed relationships with several regional organizations. Community Care Concepts out of Elmira, provides assisted/supportive living services to our residents in order that they may continue to stay at Valleyview. In addition, every year there are an increasing number of elderly residents who hire the additional people and services they need because they say that they do not want to leave their Valleyview family.

Valleyview residents continue to enjoy a variety of activities from which they can choose to participate. Over this past year activities at Valleyview have continued functioning smoothly. There is a Bible study is open to all interested participants on Tuesday evenings, a resident coffee hour, a crafters social on Monday afternoon, a regular crokinole

competition between resident and non-resident individuals from outside Valleyview, movie nights and evenings of singing by groups who visit Valleyview. Community Care Concepts provides us with a great cook for our congregate dining meal held in our multi-purpose room on the first and third Thursday of each month. They also provide our residents with a certified exercise trainer, three afternoons per week for a one-hour exercise program. The dining program is available to our residents as well as to other seniors in our community which provides the opportunity for outsiders to see the facility and interact with its residents. Also, this year we were provided with a senior support worker from Community Care Concepts, to assist our seniors on a pre-arranged appointment basis in order that our seniors can maintain their independence. I'm thankful to God for the dedication and generous giving of time by the residents of Valleyview. They are the ones who initiate and run most of these activities as volunteers, from September through to the end of June each year.

In closing, I want to emphasize how grateful I am for how our God continues to bless Valleyview year after year and myself personally, in the service I've been called to. God is forever faithful. He has shown Himself to be exactly that, here at Valleyview Manor.

Executive Summary

2016 was an exciting year for our organization! Our journey in quality has revolved around client-experience. particularly at the level of personal relationship. The Board approved a new three year strategic plan in March. Currently, the homes in aggregate have an apartment waiting list topping 1,800 individuals. The new Wellness Suites at Tabor Manor are full and running well, and in July 2016, Pleasant Manor received approval from government to redevelop its Long-Term Care home. The Pleasant Manor and Tabor Manor Foundation, the donation arm of the homes, was launched this year, which prompted a number of leadership changes within the home. We are grateful to God that even in the midst of change, He is faithful and watches over this vital seniors ministry. He has provided us with many faithful volunteers who give so much of their time to support our mission of excellence, love and dignity. We are thankful to all the tenants, residents, staff, volunteers and others who provided their input in developing our new strategic plan. The format of this year's report follows the three priorities set out in our new strategic plan.

Relational Excellence & Cultural Preservation

A top priority for us has been to engage our 322 employees in a journey of discovery in understanding relational excellence, the core aspect of customer service in our homes. We understand Relational Excellence to be demonstrated by behaviours that are Committed, Authentic, Respectful, Empathetic, Faithful, Unconditional and Loving, embedded within a supportive and inclusive community where relationships are sustained and growing. CAREFUL behaviours will guide all of our interactions with residents, tenants, families, volunteers and staff. A brief story of our faith, heritage and the organization was created and will be included in our onboarding of new staff, residents and tenants, volunteers and families. It is imperative to share this story with people who come into contact with the homes.

Innovative Growth and Partnerships

Tabor Manor's new Wellness Suites are full, with a growing wait list. After many years of work, Pleasant Manor's Long-Term Care redevelopment was approved by the Ontario government in July. Receiving this approval takes us a step closer to designing and constructing a new state-of-the-art Long-Term Care

home and is a direction consistent with past approvals by our constituency. We remain committed to communicating to our stakeholders when information becomes available respecting ground breaking. We continue to nurture and develop functional partnerships with our local academic communities with many placement programs occurring within the homes through the year.

Specialization in Dementia and Palliative Care

Our home is participating in an applied research study with Brock University and McMaster University, focused on palliative care in Long-Term Care. Over 80% of our employees have received specialized training in the Montessori Method of Dementia Care, a philosophy of care focused on introducing into resident routines, day-to-day activities designed to validate their identities, thereby increasing meaning and purpose in their lives.

Both Pleasant Manor and Tabor Manor could not function for long without the contribution of many enthusiastic volunteers. From host churches carrying out Thursday evening chapel services at Tabor Manor and chapel speakers at Pleasant Manor, to our singers, Auxiliaries and our volunteers who visit or assist in feeding our most vulnerable residents, these wonderful individuals help us fulfill our mission of serving our seniors with "excellence, love and dignity." Thank you to all who give of your time and talents to serve. This past year, we had approximately 200 volunteers, contributing approximately 12,000 hours of their time serving our seniors. That's amazing!

In addition to this report, I include a copy of our most recent issue of Reachout, the quarterly newsletter distributed within the homes, our local community and churches and select individuals across the province.

In closing, it is a pleasure and honour to serve and support our constituency in such a meaningful way through our work as a Board. We continue to be mindful of the many blessings God has bestowed on our organization and look forward to another year of service in His name.

MCC Report for 2016

Dear Friends at Ontario Conference of Mennonite Brethren Churches,

Greetings of peace, in the name of Christ.

We at Mennonite Central Committee have great cause to be thankful. You in our church community have again chosen to support the vision of "relief, development and peace in the name of Christ" through our collective MCC ministry. For this we are deeply grateful.

We are also thankful that our long and faithful history in places like Syria and Haiti positioned us well to respond to need there. We were able to say "yes" to the remarkable public interest in welcoming refugees fleeing Syrian violence and terror. We are now, early in 2017 working with over 225 sponsoring groups in Ontario with well over 600 refugees already arrived in our province through the work of congregations like those in the MB conference!

We were also able to quickly and effectively respond in Haiti to the damage from Hurricane Matthew in October. From water purification tablets to emergency food, to relief kits packed in Ontario [some prepositioned in Haiti in advance of disaster!] our response has been described by staff there as highly respectful of, and responsive to local leaders.

For the welcoming partnership we see with you in the churches, thanks be to God.

You as Mennonite Brethren congregations of Ontario have shown again how MCC is your ministry.

- 10 Ontario MB congregations gave financial gifts to MCC Ontario
- 9 Ontario MB congregations provided almost 1700 kits and blankets

These gifts, when combined with 2 international service workers, 8 staff and many volunteers from

your churches, along with your prayers, have made significant contributions to humanitarian relief efforts globally.

Let me mention several MCC highlights of the past year:

- Relief: It could be called relief. It has a strong development side. And it clearly contributes peace for the hundreds of families settled through Private Sponsorship of Refugees. Never since 1980 in the fall out of the Vietnam War, have refugees fled violence to Canada in such numbers in search of a new beginning. You in our churches responded with a Gospel generosity that has echoed across the country and around the world! Thanks be to God!
- Development: Increasingly MCC is seeing the Living Wage as a significant poverty reduction tool. We are leaders not only in paying at least a Living Wage to all our staff [\$16.05 in Waterloo Region], but also by supporting this growing national movement. And this year we moved to Living Wage "Champion" level!
- Peace: While often our peace work happens after a war ends, or in an effort to prevent violence, currently MCC is deeply involved in growing Peace Clubs. Begun in Zambia, they have now spread across Africa and Asia. Peace Clubs make it less likely that violence will be used in future when conflict arises.

Relief, development, and peace...all in the name of Christ.

MCC is a ministry of the church. We commit to carry out that ministry with the highest standards of effectiveness and good stewardship. We are deeply grateful for your role in this ministry. Thanks be to God for the generosity that begets generosity.



MDS Report for 2016

"The desert and the parched land will be glad. The wilderness will rejoice and blossom. Like the crocus it will burst into bloom. It will greatly shout for joy!"

Isaiah 35.1-2

This verse from Isaiah was the theme for Mennonite Disaster Service 2016 annual gathering. This picture is a real life experience of a blossom in a wilderness. The peony plant in this picture is in the front garden bed of what was a Fort McMurray house. It is blooming a month after the city was ravaged by fire in early May of this year.

This last year's #1 Canadian disaster was the Fort McMurray fire. Called "The Beast", the fire began on

May 1, after the driest and second warmest winter since records were kept in Fort Mac (72 years). On May 3 it raged through the city prompting a complete evacuation of its 80,000+ residents. Over 2400 structures were destroyed.

The MDS constituency has been generous in giving for Fort McMurray. We are particularly thankful for an \$80,000 MAX Mutual Aid grant that will help restore hope in Fort McMurray. We expect to begin our construction work early this spring, helping those who were uninsured and underinsured rebuild their homes and their hope. Please watch for our call out to volunteers to help us this coming year.

Other highlights from MDS Canada 2016 year include:

- The BC Unit partnered with Habitat for Humanity to rebuild a house destroyed in the Rock Creek fire.
- The Alberta Unit took on a project in Carmacks, Yukon rebuilding a house destroyed there.
- Ontario responded to an invitation from MCC Ontario to run a temporary warehouse in Elmira, ON to distribute used furniture to Syrian Refugees. The also did some work in response to flooding in Windsor.
- Manitoba, Ontario and BC hosted MDS Family and Youth projects

This year we will,

- Have a summer Family Project in New Brunswick (our first in Atlantic Canada)
- Have summer Youth Project in Ontario.
- Launch a multi-home build project for Fort McMurray.

We continue to keep our center as a grass roots movement of people like you; people who make up the Mennonite and Anabaptist communities who want to live out their faith in practical ways. Thank you for the chance to work with you to proclaim the good news of the Kingdom of God!

According to the conference's General Operating Bylaw (GOB), the mandate of the Nominating Committee (NC) is to present a slate of candidates for election who have been duly processed and discerned, to fill vacancies on both the Board of Directors and the NC. As part of its discernment procedure, the NC sent each nominee an electronic questionnaire to complete, and sent a "reference check" questionnaire to each of the nominee's personal references.

In October of 2016, all MB churches in Ontario were sent an invitation to submit nominations for the election of candidates for the Board and the NC. This resulted in only one nomination being submitted, but fortunately the NC was able to find several additional nominees, all of whom were subsequently discerned by the NC to be suitable candidates. The names of these new candidates, plus the names of two existing board members seeking re-election, plus their personal profiles, are listed at the end of this report.

The NC wishes to thank all of this year's candidates for their willingness to let their names stand for election. The NC also wishes to thank Thom Braun and Tracy Jackson for their past years of service on the Board, as they have decided not to continue. Lastly, the NC also wishes to thank Darren Milley for his past years of service as a fellow member of our committee, as he is no longer able to continue.





ONTARIO CONFERENCE OF MENNONITE BRETHREN CHURCHES 86th Annual Convention Hosted by New Hope Church Niagara 2360 First Street Louth, St. Catharines, ON

February 24-25, 2017

Theme: 'United at the Cross'

Attendance: 101 delegates, with 35 additional guests (134 present), representing 24 of our 29 member churches and 1 of our 6 associate member churches.

Pre-Conference Events:

• The 2017 Convention was preceded by a weeklong Pastor Credentialing Orientation hosted by a number of our Niagara Churches and by a Pastors and Leaders event hosted at Mountain Park Church on February 24, attended by 120 Ontario leaders.

Friday Night Session 7:00 pm to 9:00 pm

1. WELCOME TO THE CONVENTION:

Ed Willms greeted the delegates and guests of the 86th annual convention of the Ontario Mennonite Brethren Churches. Nathan Braun of New Hope Church Niagara welcomed everyone and described the unique community they serve. Nathan prayed for blessings for the Convention. Ed scrolled through a slide show of the PCO (Pastor Credentialing Orientation) event that took place during the previous week, and celebrated that many of the newly credentialed Pastors were in attendance.

2. WORSHIP AND PRAYER:

Matt Unruh introduced the worship band made up of members of many of our Niagara MB churches. Together they led worship, singing This is Amazing Grace, Revive Us Again, Nothing is Holding Me Back and At The Cross

3. LEADERS COLLECTIVE:

Ed Willms introduced Robyn Serez of MB Missions. Robyn is the director of the Leaders Collective, which was introduced last year as a supplemental leadership track designed to empower and equip promising young adults engaged in ministry within the MB church community in Ontario. She asked the attendees to recollect those who have mentored them and provided leadership that has helped them grow. Robyn explained how the Leaders' Collective works to support, encourage and challenge these young leaders and to provide opportunities for them to develop their leadership gifts through ministry partners (C2C, MB Missions, Camp Crossroads). Robyn invited those interested to attend the Leaders Collective breakout session tomorrow to learn more.

4. CCMBC UPDATE:

Bruce Enns (Moderator) and Steve Berg (Interim Executive Director) of CCMBC provided a video update of changes that have occurred over the past few months at CCMBC prior to the departure of Willy Reimer. They explained how CCMBC will continue to build upon Willy's foundation, with the goal of strengthening the relationship with OCMBC. We share a focus and mission and are stronger working together. Steve shared that, in the fall of 2017, a motion will be brought forward that MB Mission take over and assume the responsibilities of C2C. At the completion of the video, Ed introduced Bruce Enns (in person) who brought greetings from CCMBC and reiterated the goal of working more closely together.

5. KEY-NOTE SPEAKER 'ONE LEADER':

Ed introduced Mark Wessner, President of MB Seminary, and prayed for Mark's message. Mark participated in the PCO this week and shared how impressed he was with the new leaders, two from Manitoba and the rest from Ontario. Mark told the story of his unprepared participation in a Spartan Race. His only goal was to finish the race, but he finished 4th in his age category. This motivated him to work-out and better prepare himself for the next race. Despite his preparation, he completed the second race 78th in his category, and in his sock-feet. He received a participation medal which, for Mark, symbolized his determined

Continued

struggle in adversity. He related this experience to the crucifixion in 1 Cor. 1:2-17. Paul writes to the dysfunctional and divisive Church in Corinth and states that, in Christ, they are enriched in every way. God is faithful, even when our churches are broken and messed up. Christ sent Paul, not to baptize, but to preach the gospel at the cross. Paul described the gospel as a perfect leader dying for an imperfect people. Mark shared the experience of a division within his own church which led to the departure of the lead Pastor. He preached on this passage in 1 Cor. 3:4 "Some say I follow Paul.... Apollos.... Is Christ divided?" If you think it is the Pastors' church, or anyone other than Jesus Christ, you are actually committing adultery. The Church is the bride of Christ, and God is faithful. We need to acknowledge that the church has one Leader, and that leader is Jesus Christ. To do otherwise is foolish. Mark challenged us to reorient and repent. If we find ourselves following a human leader, we need to recognize our error and declare that we have only one leader, and He is Jesus Christ. Ed prayed for those who gathered at the cross to make a symbolic stand of unity under one leader.

6. WORSHIP, COMMUNION & PRAYER:

The worship band led in Lord I Need You. Following scripture reading, Ed summarized, if we were only more discerning with regards to ourselves, we would not come under such judgement. We don't only need to preach it, we need to live it and model it. When trust is broken, it takes time to rebuild. Sometimes it is hard to forgive, but with God we must struggle to make things right. He prayed for Communion, which was shared around the tables. The worship band played Seas of Crimson, Stronger, The Wonderful Cross and In Christ Alone (Solid Rock).

7. OFFERING, NOTICE & CLOSING:

Ed Willms gave instructions for breakfast at 8:00 am, and the events planned for tomorrow. He also explained the opportunity for financial support for the Conference and for the work of the Leaders' Collective.

Saturday, February 25, 2017 8:00 am – 12:10 pm

A continental breakfast buffet was enjoyed by all. Many thanks to the New Hope Church Niagara community.

8. WORSHIP BAND:

The worship team led in song: Jesus Paid It All and The Same Power.

9. WELCOME:

Ed Willms welcomed the delegates to the 86th Convention and thanked everyone in attendance. Ed introduced Mark Wessner, our new MB Seminary President from Abbotsford BC, and prayed for his message this morning.

10. KEY-NOTE SPEAKER 'ONE MISSION':

Mark shared his prayer requests for the MB Seminary. He then asked, 'Have you ever been a part of a team where everyone wanted to go in different directions all at the same time?' The experience is frustrating, exhausting and unproductive. With this in mind, Mark read from 1 Cor. 1:7 - 17. Even in their confusion, God is still faithful and has gifted the Corinth church. The message of the cross is the power of God and it unites us for one mission. 1 Cor. 15:1-8 You need to be continually reminded of the primacy of the gospel. the death and resurrection of Jesus Christ. How is the message of the cross the power of God? 1 Cor. 1:18-25. The weakness of God is stronger than human strength. If preaching rests on human wisdom, then those who hear will not rest their faith on God's power. Mark shared an experience when, at the end of a Sunday service, he called people to repent and be baptized NOW, with no prior announcement. Twentysix people came forward. They repeated the call the following Sunday and nineteen more people came forward, in a church that had traditionally had only ten or twelve baptisms per year. The message of the cross has power. All we have to do is proclaim it. God moves powerfully when we dwell in the scripture. God brings order out of chaos; judicial order, cosmic order and relationship order. In the end, God will bring order out of chaos. While we can do good things that are not gospel-centred, as leaders, the gospel needs to be the conscious core of everything we do and that

we maintain a sense of urgency in our one mission to reach as many people as possible. Mark challenged us to look to our own lives and identify our one mission and determine what we need to change in our own lives in order to urgently pursue that mission.

11. WORSHIP:

Mark closed in prayer and the Worship Team lead in Revive Us Again.

12. BUSINESS SESSION & CALL TO ORDER:

Jeff Janzi, Chair of the OCMBC, thanked Mark for the challenge. He then opened the business portion of the agenda. There will be two breakout session times this afternoon and Jeff explained the purpose of these events, which will provide information within an intimate space where delegates may ask questions. Jeff referred delegates to review the complete version of the conference e-book on the OCMBC website. Jeff introduced Shelley Campagnola, who confirmed that the quorum requirements for the 2017 Annual General Meeting have been met. Jeff introduced the individual members of the Board of Directors and also Ed Willms, Executive Director and his assistant, Kristi Lee, who worked hard in preparing for the AGM and preceding events.

MOTION 17-8 MOVED, SECONDED and CARRIED that the agenda be accepted as presented.

MOTION 17-9 MOVED, SECONDED and CARRIED that we receive the committee and board reports as distributed in advance in the e-version convention booklets and as handed out at the door.

MOTION 17-10 MOVED, SECONDED and **CARRIED** that the minutes of the OCMBC AGM/Convention 2016, be approved as distributed.

13. BOARD OF DIRECTOR'S REPORT:

Jeff highlighted the Board of Director's Report and reminded the delegates of the OCMBC Mission Statement. 'To glorify God by multiplying disciples of Jesus Christ through our member churches by facilitating collaboration, providing accountability and encouraging blessing.' As a Conference, we must never lose focus or take our eyes off this mission. Jeff referred to our ongoing partnership with the

Canadian Conference...we want to work better together. What does it look like for us in Ontario to intentionally choose to strengthen our partnership nationally? Independently, the Ontario and National Conference have developed very similar mission statements, which indicates that we clearly share the same mission. The CCMBC Mission Statement is, 'We exist to multiply Christ-centred churches to see Canada transformed by the good news of Jesus Christ.' Jeff acknowledged our appreciation for the work of Ed Willms and Kristi Lee, who are employed daily in the actual work of the conference. Jeff and the Board laid hands on and prayed over Ed.

14. NOMINATING COMMITTEE REPORT:

Jeff referred to General Operating By-Law Section 8.2. He outlined the rationale leading the Board to present the following resolution to this Convention.

MOTION 17-11 MOVED, SECONDED and CARRIED to accept the Board resolution that Karen West be permitted to serve up to a maximum of five additional consecutive years on the Board of Directors of the Ontario MB Conference, with a maximum term to end in February 2022.

Jeff introduced Ron Willms, Chair of the Nominating Committee, who explained the process by which positions on the Board of Directors and the Nominating Committee are filled. The Nominating Committee has discerned three new candidates for Board positions (Mandy Kasper, Adam Knowles and Alex Suderman), and two existing Directors seeking re-election (Shelley Campagnola and Karen West), to fill all of the vacancies on the Board.

15. FINANCIAL REPORT - 2016:

Shelley Campagnola presented the audited financial statements of the Ontario Conference of M.B. Churches for the year ended December 31, 2016. This is a year to celebrate the relationship with and between the churches who have stepped up their support of the mission of the Ontario Conference. Shelley reviewed the financial report line by line. Our income has increased over last year and, while we have a year-end deficit of \$101,521, it is less than that which had been budgeted. Fund balances were reduced to cover the deficit. 86% of our income came from 21 contributory churches. In addition, 6.8% of our total revenue came from individual donors. Shelley reviewed the audit process, policies and governance.

MOTION 17-16 MOVED, SECONDED and **CARRIED** that the audited financial statements for 2016 be accepted.

MOTION 17-17 MOVED, SECONDED and CARRIED that Bridgman and Durksen be appointed as auditors for 2017 and that the Board of Directors be authorized to set the remuneration for these auditing services.

16. PANEL DISCUSSION ON THE "BIG IDEA":

Karen West introduced herself as the Ontario representative on the CCMBC and Moderator of this panel discussion. Karen introduced the panelists:

Karen asked the candidates to share their understanding of the 'Big Idea'. Larry provided the MB Missions perspective. Immigration has impacted our nation significantly and workers are being sent from everywhere to everywhere. The Lord of the harvest is bringing the mission field right into our back yard. Mark B. shared that, from a C2C perspective, the heart of the urban centers continued to prove difficult to reach. Increasing globalization has led to cultural diversity in these communities for which we may not be well equipped. With 1 in 5 Canadians living in the golden horseshoe, we need to work together on this one mission. On the other hand, many small rural community churches are closing. Larry expressed a desire to better position our leaders to assist with the individual church challenges. We are the missionaries, and as more and more people have no Christian memory, our one mission is to reach the unreached. Mark W. shared his memories of students leaving home to go to university and then never coming back. The same story applies in Ontario, where we have churches full of young people who need to go elsewhere to pursue their national seminary studies. We are working now to partner with Tyndale Bible to offer post-graduate divinity studies under the MB banner in Ontario. Bruce is also a local church Pastor in Saskatoon and he acknowledged that it is necessary to be part of something bigger than yourself. Serving on MB Missions Boards has been life-giving to him as a local Church Pastor. The vision of one mission together places us at the centre of mission work wherever we find ourselves, whether within our local church or in the mission field. To be connected to something bigger matters. The collaboration continues between the Provinces. Karen thanked the panel participants.

INTRODUCTION OF MINISTRY REPORTS:

Trevor responded to a question card with regards to the functional model employed by C2C.

19.EXECUTIVE DIRECTORS REPORT:

Ed Willms publicly acknowledged and thanked the Lord for his restored health. Leading into his ED report, Ed referred to the four areas of the Ministry Model. Under 'developing leaders', we are trying to come under and support the vision of the local Churches. The Leaders Collective, the leadership seminar with Bruxy Cavey, the new seminary project with Tyndale are all efforts to support and facilitate the local churches. Under 'multiplying churches', C2C is working hard. Ed told about an unused United Church that exists in the native community near Camp Crossroads. Their leaders invited Derek Parenteau to assist them and his efforts may lead to the first First Nations MB church in Ontario. Under 'building community', we just finished the PCO in Ontario and leaders were able to connect with and support each other. Ed was also happy to report that Kitchener MB Church invited L2L and Dave Jackson to participate in a community building undertaking with the goal of re-engaging. Under 'resourcing ministry', the active giving of our churches is on the rise and needs to be applauded and encouraged. This year, a number of churches are embarking on significant investment projects that give witness that God is moving in our communities.

20. PROPOSED 2017 BUDGET:

Shelley Campagnola acknowledged that we embrace and give witness to a generous God and budget-setting is not only about the numbers but also about the vision. Shelley explained changes to the actual budget from the draft budget that had been distributed in advance of the meeting. For 2017, the budget projects income of \$200,000 and expenses of \$270,000, which means that we expect to dip into the reserve funds again in 2017 for \$70,000. Shelley researched the finances of the Ontario churches and has determined that, if each church gave 2.2% of their budget in 2017, we would run a surplus OCMBC budget.

MOTION 17-18 MOVED, SECONDED and **CARRIED** that the operating budget for 2017 be approved a presented.

Cober-Bauman brought greetings from MCC.

21. CAMP CROSSROADS:

Ed Heinrichs and Andrew Hiebert reported that 249 significant spiritual decisions were made at Camp last year. Year-to-date, 661 individuals have registered for Camp, up significantly from the same time last year. Camp has only one mission, to be Christ-centred in all of their activities, supporting the local churches and sending better equipped leaders back into their communities. This week, Camp has been interviewing LIT's (Leaders In Training), and this is a very exciting time. These are the leaders of tomorrow.

22. MB SEMINARY REPORT:

Mark Wessner played a video featuring cross-cultural ministry educational opportunities offered to students at MB Seminary. Ben Wohlgemut shared his story about his ministry training 40 years ago in Fresno California. Training is now available in Canada through partnerships that have been developed. At MB Seminary, there are 78 students, 14 in Winnipeg, 64 in Langley, 40% are full time, 33% female, 80% are from MB churches. Courses are quite affordable with some grants available for MB students. Many courses are available on-line and in short-format. The Tyndale connection is an exciting new development. Please pray for the seminary.

23. MB MISSION REPORT:

Philip Serez played a video showing 100 war orphans experiencing the ocean shore for the first time. Under the new initiative, 'building leaders for peace', there is good news for the Middle East. Leaders have returned to their home towns bringing with them acts of peace. The Kingdom of God is coming nearer in these places because MB Missions showed up and answered their questions about Jesus. Everyone can be a peacemaker through collaboration. Sending workers - mobilizing, collecting, witnessing. Planting churches – gathering, equipping, growing with them. Building Capacity – multiplying capacity in the historic churches.

24. EDEN HIGH SCHOOL REPORT:

John Bryan showed young yearbook photos of leaders in our MB community today. Eden is not just about four years of our lives, but it provides a strong foundation. Eden engages the students by providing many opportunities (chapel, music, retreats, SOAR) for them to come to know God better. 

INDEPENDENT AUDITOR'S REPORT

To the Members of Ontario Conference of M.B. Churches

We have audited the accompanying financial statements of Ontario Conference of M.B. Churches, which comprise the statement of financial position as at December 31, 2016 and the statements of combined revenues and expenditures, changes in net assets and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Basis for Qualified Opinion

In common with many non-profit organizations and consistent with prior years, Ontario Conference of M.B. Churches charges capital assets against operations. As well, Ontario Conference of M.B. Churches derives revenue from donations, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of Ontario Conference of M.B. Churches. Therefore, we were not able to determine whether any adjustments might be necessary to donation revenue, excess of revenues over expenses, and cash flows from operations for the year ended December 31, 2016 and December 31, 2015, current assets and net assets as at December 31, 2016 and December 31, 2015.

Qualified Opinion

In our opinion, except for the possible effects of the matters described in the Basis for Qualified Opinion paragraph, the financial statements present fairly, in all material respects, the financial position of Ontario Conference of M.B. Churches as at December 31, 2016 and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Notes to Financial Statements



1. DESCRIPTION OF ORGANIZATION

Ontario Conference of M.B. Churches (the "Conference") serves a constituency of member churches in the Province of Ontario. It provides general denominational oversight and facilitates the operation of joint initiatives and gives guidance to the separately incorporated agencies of the denomination which are operating in the province. The Conference received its Letters Patent as a non-share capital corporation from the Province of Ontario in 1932. As a registered charity under the Income Tax Act, the Conference is exempt from tax on its income.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO).

Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

Net assets

- a) Internally restricted net assets are funds which have been designated for a specific purpose by the organization's Board of Directors.
- b) Unrestricted net assets comprise the excess of revenue over expenses accumulated by the organization each year, net of transfers, and are available for general purposes.

Designated fund exclusions

The Conference is sometimes the conduit for certain designated funds to flow through its accounts to the designated recipient. These flow through amounts are not disclosed in these financial statements, but are recorded in the ultimate recipients' financial statements.

Fund accounting

Ontario Conference of M.B. Churches follows the deferral method of accounting for contributions.

Revenues and expenses related to program delivery and administrative activities are reported in the General Operating Fund.

Revenues and expenses related to program delivery and administrative activities for Moveln and Malkutha Church are reported separately in their own related funds. During 2015, Moveln and Malkutha Church became separate entities and therefore their revenues and expenses are no longer reported in the Conference's financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Cash and cash equivalents

The Conference's policy is to present bank balances net of outstanding cheques and deposits under cash and cash equivalents.

Capital assets

Capital assets are recorded at a nominal charge. The cost of additions are charged to expenses at the time of purchase. Management has decided to not recognize capital assets and remove the expense in the statements of revenues and expenditures in accordance with ASNFPO. Changing the presentation to capitalize expenditures from operations may reduce useful information to the primary readers of these financial statements as they would now appear on the separate statement of financial position, and not against the budget.

Contributed services

The operations of the organization depend on both the contribution of time by volunteers and donated materials from various sources. The fair value of donated materials and services cannot be reasonably determined and are therefore not reflected in these financial statements. Certain larger material contributions are recognized at their fair market value.

Budget information

The budget figures presented for comparison purposes have been approved by the Board of Directors. They have not been subject to audit, review or other tests and procedures. Consequently, our opinion on these financial statements does not extend to them.

Financial instruments policy

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expensed when incurred.





3. DESCRIPTION OF FUNDS

The General Operating Fund accounts for the Conference's program delivery and administrative activities. This fund reports unrestricted resources and restricted operating grants. \$50,000 is allocated to a separate General Operating Fixed Minimum Fund.

The Mortgage Receivable Fund account was established in April 2008 when the Covenant Orthodox Presbyterian Church bought the former Komoka Mennonite Brethren Church. The Conference granted a mortgage to Covenant Orthodox for \$243,000 with payments of a \$1,000 a month for four years totaling \$48,000. The final payment of \$195,000 was received in December 2011. The remaining fund balances will be used in the future for purposes other than operations. In 2016, \$80,000 was transferred into the operating reserve to support the C2C donations.

An Emergency Fund of \$25,000 was created out of the Operating Fund on December 31, 2005 to support any church's pastor (or family) in the case of sudden financial curtailment. An additional \$25,000 was transferred into the emergency fund in 2012 from the now unused Covenant (Komoka) Mortgage Fund.

The Ministry Development Fund's purpose is to financially support a Leadership and Organizational Development Plan, specifically outreach and leadership development activities by churches, ministry boards, and individuals in the Conference. Up to \$50,000 is made available per year maximum of \$10.000 per church. During the year, this fund was depleted.

The Moveln Fund was established during 2010 fiscal year. The purpose of the fund is to support praying teams of Christians to "move in" to socially and economically disadvantaged neighbourhoods in Toronto. In some cases, churches will be planted, and in others, individuals or teams will function as lay missionaries. Moveln obtained registered charity status in 2015 and the Conference is no longer collecting revenue in trust and paying all expenses on its behalf.

Malkutha Church is a subsidiary of Moveln. Beginning in 2015, the Conference is no longer collecting revenue in trust or paying expenses on their behalf within the Malkutha Church Fund.

The Special Project Fund was established to segregate any special projects outside the normal course of operations.

4. INVESTMENTS - CANADIAN CONFERENCE

The investment is with the Canadian Conference of MB Churches earning interest at a base rate of 2.00%. See note 6 for interest rate risk.

5. DUE TO RELATED PARTIES

The Conference has transactions with numerous related parties (member churches) or organizations that are funded by the Conference. These financial statements do not determine, disclose or verify all such related party activities.

6. FINANCIAL INSTRUMENTS

The Conference is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the Conference's risk exposure and concentration as of December 31, 2016.

6. FINANCIAL INSTRUMENTS (continued)

Interest rate risk

Interest rate risk is the risk that the value of a financial instrument might be adversely affected by a change in the interest rates. In seeking to minimize the risks from interest rate fluctuations, the Conference manages exposure through its normal operating and financing activities. The Conference is exposed to interest rate risk through its investment savings account balance.

Constituency dependency risk

As the Conference serves the member churches, it is dependent on these member churches for financial support.
