



# RE-ENGAGING OUR CHURCHES

A top priority in 2023 has been engaging with our churches and leaders on a relational level. This meant much time on the road to join worship gatherings and to share meals or coffee with our great pastors. The intent has been to rebuild trust and relational strength with our churches. A highlight was gathering our four Ottawa MB churches for a shared worship service in November for the very first time!

# PURSUING 'TOV' & CONTINUED LEARNING

Tov, the Hebrew word for 'good' has been a theme for our churches as we've considered how to foster cultures of goodness. We've used *A Church Called Tov* by Scot McKnight and Laura Barringer as our guide, and many have contributed via written and spoken reflections on our ONMB blog, Jesus Stories podcast and in Team of Teams calls. Whole church elder teams have engaged as well. May our churches be places where all people can thrive in the fullness of God's goodness!



At the 2023 Convention, our Provincial Faith and Life Team (PFLT) committed to continued growth in care for and discipleship of LGBTQ+ persons. Throughout the year a group of 6 pastors across ONMB have participated in a cohort by Revoice, being coached by a celibate pastor with same-sex attraction. We've also hosted four LGBTQ+ Care and Discipleship Zoom conversations for all ONMB church leaders. Here we learned from three same-sex attracted persons and one parent of a non-binary child, all of whom are committed to a traditional sexual ethic.

Healthy Leaders Training has been developed by the PFLT, to provide training in the realm of pastoral vulnerability and power dynamics. This will be completed by all credentialed leaders once every five years. This is a critical step in empowering our leaders to engage wisely in the many relational complexities we encounter as pastors.

### **CCMBC ENGAGEMENT**

Serving with the National Ministry Team in 2023 I worked with CCMBC leaders, Provincial Leaders and National Ministry Partners (Legacy, MB Seminary & Multiply) to continue to develop strategy for our Collaborative Unified Strategic Plan (The CUSP). We're beginning to see the fruit as we learn about the Leadership FrontCounter being developed with MB Seminary taking the lead. This will facilitate better formation for our leaders across Canada to engage the complexities of this time with the Good News. Multiply is also leading our collaborative work on our CUSP mission strategy which you'll hear about in the coming year.

I'm grateful for the work of Elton DaSilva as our National Director and excited for the incoming National Director, Cam Stuart. Elton served us well with courage through a season that included many speed-bumps. Cam brings a determined but wise and gentle approach to collaboration and a passion for disciple-making cultures in our churches.

The EQUIP National Conference was a great success! We had approximately 35 participants from Ontario as we gathered with approximately 220 MBs from across the country to ask the theme, "Fire and Ashes: Why Church? Why MB?" My observation is that we're entering a season of increased national unity and readiness.

### HIGHLIGHTS OF NOTE

- •Three days in Dartmouth, NS to encourage and learn from The Well Church and their pastor, Adam Greeley. The Well is one of two MB churches in Atlantic Canada and thus in need of relational connection.
- •Gathering pastors through the spring for regular prayer in Niagara, KW and the GTA.
- •ONMB Board Retreat in May: a time of seeking understanding and healing related to the past year and seeking God's direction forward. We examined our current place in the entire history of ONMB, using the Journey Wall process from years prior. We have an excellent Board of Directors who lead with faith-filled humility and courage.

### **CHURCH & PASTOR TRANSITIONS**

Three great new Lead Pastors and one Transitional Pastor have been placed in our churches in 2023. God has provided:

- David Wicks, Kingsfield Zurich Mennonite Church
- Michael Thompson, Christian Fellowship Chapel
- Stephen Sesink, Evergreen Heights Christian Fellowship
- Jacob Birch, New Life Christian Church

Chris Walker of Meadow Brook and Timothy Quek of New Life

Christian Church both completed their time as Lead Pastor with their churches. I'm grateful for the leadership and service of both pastors.

In 2023, Living Hope Bible Church (Port Rowan MB) withdrew from membership with ONMB, citing a more conservative theological trajectory. We're grateful for their long-time partnership and are sad to see them step away. However, we pray for the fullness of God's blessing and encourage partnership with a network of churches with whom they feel they can align

and thrive with.

In 2023, Grace MB also voted to formally close with their people merging with Radiant City Church to become Belmont Village Church. This merger is in process and BVC is on track to become an Associate Church with ONMB. We are grateful for Grace's participation with ONMB for twenty-three years. We recognize that this has been a challenging time and not an easy decision for the Grace MB people. We join with them in both sadness and hope for the future.

### MISSIONAL EXPRESSIONS

Unfortunately, due to my shift to the Interim Executive Director role, Missional Expressions leadership for new disciple-making initiatives and church plants received limited attention. I am grateful for the ongoing growth of our most recent church plants, Southeast City Church and Bytown Community Church. We've partnered in the launch of PowerServe with Darren Milley. This is a Disciple-Making initiative in the trucking industry. Life Point has also relaunched in a new storefront location. Multiply workers also continue to invest in disciple-making in Indigenous and Tibetan communities in Ontario. We also hosted a disciple-making movement training event by Derek Parenteau with 16 leaders across ONMB in the spring.

I'm excited to begin giving 50% of my focus to this realm once the Executive Director baton has been completely passed. There are good dreams and ideas stirring as our Missional Expressions Team has sought God's vision for ONMB.

### **NEW EXECUTIVE DIRECTOR**



ONTARIO CONFERENCE OF MENNONITE BRETHREN CHURCHES 92nd Annual Convention Hosted at Maple View Mennonite Church, Wellesley ON

Feb. 24-25, 2023

Theme: "In Our Brokenness Jesus Shines"

Attendance: 91 Convention Members, representing 20 of 26 member churches, plus additional guests and 1 of our 4 Associate Member Churches.

Friday Night Celebration Service: 7:00 pm to 9:00pm

#### **Welcome and Introductory Comments:**

Kristi Lee and Brent Kipfer welcomed everyone to the 2023 ONMB Convention at Maple View Mennonite Church in Wellesley, ON. Brent shared the history of Maple View and how it ties into the Mennonite Brethren story. Kristi introduced the theme, "In Our Brokenness, Jesus Shines." Kristi opened in prayer.

#### **Worship in Music:**

A team from WMB Church, led by Shawn Branton opened the worship music with "God So Loved" and "This is Amazing Grace".

#### **Acknowledging Our Brokenness:**

Board Chair, Michelle Knowles celebrated the opportunity to gather in person again after two years of meeting online for Convention. We come with both thanksgiving and brokenness in our personal lives and in the conference of churches. The absence of Ed and Karin Willms was acknowledged with sadness and thankfulness was expressed for Ed's ten years of leadership with ONMB. Michelle prayed a blessing upon Ed and Karin.

#### **Guided Prayer:**

Meghan Plett, an ONMB Board Member led in a "Palms Up, Palms Down" prayer to settle ourselves through connecting with Jesus.

#### **Plenary Address:**

Bruce Enns, General Director with Multiply preached from 2 Corinthians 4:5-7 on the theme "In Our Brokenness, Jesus Shines." We are called to be witnesses to the light of Jesus both individually and corporately. However, this light is threatened by division and brokenness as the darkness creeps into the church. And yet, it is in the spiritual community where our stumbling toward Jesus takes place. Leonard Cohen's song Anthem declares, "There's a crack in everything. That's how the light gets in." While we may be stumbling, we are still called to be witnesses and this brokenness enables the light of Jesus to shine brighter. Bruce shared his own season of personal burnout and how Jesus shone through that experience. The closing statement was "May we lift our eyes to trust the Spirit is at work in our dark places so that we may follow Jesus into his great mission together."

#### **ONMB Story:**

Dan Chook Reid, church planter with Bytown Community Chair shared how Jesus has shone through his brokenness. As God has led Dan through a journey of cancer, and a tumultuous leadership journey, he has discovered the power of Jesus amid his brokenness. This led to the planting of Bytown CC. He also noted the significance of the ONMB family as a support through the journey.

#### **Mosaic and Communion:**

Ryan Jantzi expressed thanks to all who have gathered and hosted this Convention, as well as to Bruce Enns for his address. He led through the corporate creation of a tile mosaic to concretely represent how Jesus shines in our Brokenness. Together, the Convention attendees remembered and honoured Christ's work at the cross through sharing in the Lord's Supper. Leaders Collective participants assisted in administering communion. The Worship Music Team lead in "Gratitude", "Great Are You", "Whole Heart" and "Glorious Day".

#### **Closing Comments and Prayer:**

Ryan Jantzi invited Joel Martin of Multiply to pray for healing and blessing upon Philip Serez who has ALS. Joel invited Trevor Seath of C2C Collective to join him in this prayer. This was a powerful symbolic moment of C2C and Multiply standing side-by-side given the recent story of the Multiply and C2C demerger. Ryan invited attendees to embrace this truth that Jesus shines in our brokenness as decisions are made in the Saturday AGM, even as those decisions may be difficult. The service was closed with prayer at 9:00pm

Jeff MacLeod welcomed everyone, giving instructions for Convention Members to sign in if they haven't already and invited us to focus today on what God is doing in the midst of all the challenges and transitions we are facing.

Ryan Jantzi gave opening comments around our theme of In Our Brokenness Jesus Shines, recapping our time together last night. Jesus experienced brokenness so we can become whole.

**Spiritual Healing Panel Discussion:** Journeying Toward Wholeness with Andrew Plett (Mountain Park Church), Dave Bretzlaff (South Point CC), Susan Friesen (Meadow Brook Church)

Covid revealed much of our brokenness.

Susan recognized that they needed to do something but didn't yet have tools to address it.

Dave continually got calls from people who were looking for more support and counselling. While not a big program person, Celebrate Recovery has provided structure to help people experience healing.

Andrew recognizes that having doctrinally correct answers to questions doesn't mask the brokenness going on underneath. Noticed the Church splintering over theological/ethical/social issues. He had people in his office every week expressing their strong convictions with anger and bitterness. There was a brokenness in their soul and hearts. Pastors often lead from a place of brokenness that gets masked with programs, information, theological training. Leading out of a place of insecurity, fear, and control. As leaders instead of bringing the Kingdom to bear in our churches, we're in the midst of the dysfunction. From personal struggles with control and fear, the question of how to lead others into peace and hope arose. Mountain Park took their staff through Freedom Session (it's a 20 week intensive healing discipleship process) and then rolled it out to the whole church in the fall. There are people who are being healed from trauma, abuse, and generational baggage. People who are experiencing deep, personal relationship with Jesus. Jesus is setting people free, restoring and renewing them, stepping into their lives tangibly.


Dave's church started Celebrate Recovery as a 12 step program for people with hurts, habits, and hangups. When people are hurting, everyone around them is hurting too. CR takes that collective of people to help them too.

Susan shared that Meadow Brook has been using Soul Care (book and video study) that's designed to go through with one other person, allowing the Holy Spirit to reveal areas deep in your life where you're stuck, wounded. You become authentic with other people. Goes through 7 principles that can bring great healing. They have seen a lot of freedom in a lot of lives through this ministry. Such great healing from fear, insecurity, shame, unforgiveness. Relationships restored, physical healing, real encounters with Jesus, falling in love with him.

#### **BUSINESS SESSION PART 1:**

Michelle Knowles and Doug Valerio offered a welcome and introduced themselves as well as the agencies with tables in the foyer. They also introduced our National Leaders (Elton DaSilva, Ken Esau, Jason Krueger, Mark Wessner, Bruce Enns, Kara Friesen, Carson Samson).

They gave instructions for voting delegates about the voting process with the voting cards and ballots. There is an invitation to give to Bytown Community Church this weekend, to bless them with our generosity, so they can continue their mission in Ottawa.

#### **CALL TO ORDER/QUORUM:**

Quorum bylaw 7.4 requires 50 voting representatives present, in person, representing at least 50% of member churches. We have 20 of 26 member churches represented with 91 delegates present at the beginning of this session, plus 34 guests. One of our 4 associate member churches is also represented. The quorum requirements have been met.

MOTION C23-2 MOVED, SECONDED and CARRIED that the agenda be accepted as presented.

**MOTION C23-3 MOVED, SECONDED and CARRIED** that we receive the Committee and Board Reports as distributed in advance in the Convention book.

**MOTION C23-4 MOVED, SECONDED and CARRIED** that the minutes from Convention 2022, as presented in the Convention book, be approved.

#### ONMB INTERIM EXECUTIVE DIRECTOR REPORT:

Ryan acknowledged that this year shaped up differently than expected, which has brought much grief. Expressed gratitude for Ed Willms' leadership of ONMB for the past 10 years. Ryan is honoured to lead as the Interim Executive Director at this time, and loves these churches. Has a passion to facilitate the collaboration of churches. Believes that we're healthier when we partner together well. Expressed thanks to Kristi Lee, Jeff MacLeod, and Michelle Knowles, as well as the full Board of Directors and PFLT.

Ryan acknowledged sadness about the motions regarding Southridge, FreeChurch, and the withdrawal of New Hope last year. We long to align so we can partner well in ministry together.

There is much hope for 2023. To enter into a season of prayer, seeking God about what he's calling us to. There will be opportunities to invite everyone into this, not just the Board. There will be a renewed space and capacity for a greater focus to multiply disciples of Jesus.

Ryan expressed disappointment about being unable to focus on Missional Expressions to the extent he had hoped this last year, to plant churches and make new disciples.

We will be having conversations based on Scot McKnight's Book of Tov - how do we form communities of shalom. We will continue to care for and shepherd our pastors, be a sounding board, pray with, and encourage them. We will continue to learn and grow in our care for and disciple 2SLGBTQ+ people.

Ryan shared that we won't have a pastors retreat this year, but have plans to host one in May 2024. Ryan will work to strengthen trust between churches and the board, encourage pastors and leaders, and work together with the board to discern where God is leading us.

#### ONMB BOARD CHAIR REPORT:

Michelle reviewed the year, touching on the disappointments and hopes of renewal. What had felt hopeful in the spring, by the fall we entered into a very turbulent season which resulted in the release of Ed Willms, shifts on our Board, and Ryan entering into a new role. There is grief and trauma attached to this; yet we also saw hope. Our churches pressed in, rather than pulled away. Clarity of our shared convictions, encouragement, support, and generosity brought much hope amid turbulence. We see God at work and are grateful for the ways the churches have pressed in together. She extended a huge thank you to Ryan and Kristi. So grateful for staff who love God and love the churches in our ONMB family, who pour themselves out. We have challenges and significant decisions to make together today, and also have much hope before us. The outcome of these decisions will guide where we go from here. We seek to steward well what you've entrusted to us, to carry out the purpose and direction of the Conference, and to trust God as he leads us forward.

Doug welcomed everybody back.

Doug clarified the voting process regarding who is welcome to ask questions or make comments during the discussion - only for delegate voters and registered guests (at Michelle and Doug's approval).

#### **Camp Crossroads Report:**

Andrew Hiebert expressed gratitude to our churches for support - financially, volunteering, serving with skilled trades, etc. So thankful for the way God has provided through the pandemic. God is using chapel ministry on retreats this winter to change students' lives. Theme verse: Psalm 16:11. We want to show people the path of life. We value the next generation. We help make Christ known through camp retreats throughout the year, church retreats, and summer camp programs. Currently ~630 students (capacity 960) signed up for camp programs.

To help support Camp Crossroads, pray for them, tell others about camp, volunteer your time, and support financially. There's a work week in April that you can come up and help work around camp to get it prepared for future ministry.

#### **ONMB Financial Report:**

Noah Grossman summarized his report as found in the Convention book pages 36-39.

We had planned for a \$27,000 deficit, but came in at only \$18,000 deficit. There's affirmation of how God is taking care of us.

We have a desire to continue on the same path and vision that was established in previous budgets, to continue the momentum. We have also proposed that the remainder of Ed Willms' severance be taken out of the Operating Reserve fund, leaving us in a surplus budget.

We propose that we do a review engagement for 2023 rather than a full audit, as allowed this year under ONCA rules. The main benefit is fiscal - about half the price of a full audit.

Karen West presented

One PFLT member serves on the NFLT to ensure collaboration across our whole country.

The primary function is to safeguard MB theological convictions and biblical interpretation as given in our Confession of Faith (CoF) which outlines our best, collective, communally discerned understanding. Every article is as essential as the others - the document is to be seen as a whole. It's a rich discipleship tool which sets out and defines what we wholeheartedly believe is God's very best plan for abundant life for all people as understood through Scripture. Designed as God's gift to the world in both good and turbulent times.

#### 2 main functions:

- facilitating the credentialing process using a National tool
- guiding and supporting MB churches as they apply our common understanding of Scripture in their contexts.

Over the past few years, we have been journeying with FreeChurch Toronto and Southridge Community Church as they have broken the common covenant together around our understanding of marriage to be limited to one man and one woman but now hold a different belief of marriage. It has become clear that both FC and SCC have chosen a path that no longer embraces our CoF.

There is a place for everyone in Christ's church. As a discipleship call, we believe that faithful Christian living includes celibacy or committed marriage between one man and one woman. Continuing down this path would undermine all our beliefs. We have not always loved 2SLGBTQ+ people well, and ask their forgiveness, and commit to doing better.

#### **Board Report:**

Michelle offered gratitude to the PFLT for their weighty work, for their posture and discernment.

These motions have implications for all our churches. Should we allow members to hold any articles in our CoF as disputable matters, to do so would put at risk our legal standing as well as our standing with our National Conference.

We don't bring these motions lightly, but humbly and with deep conviction that they are the right next step in continuing to live into the fullness of our convictions.

#### **PFLT Motions:**

**MOTION C23-15 MOVED, SECONDED and CARRIED** that having followed the procedure of the GOB 6.8.1, and in accordance with the GOB 6.8.3, we move that the membership of FreeChurch Toronto in the ONMB Conference be revoked.

Mike VandenEnden, Grantham MB - the absence of FreeChurch here today speaks clearly

Glencairn - affirm the work of our PFLT and Board on this motion and the next.

**MOTION C23-16 MOVED, SECONDED and CARRIED** that having followed the procedure of the GOB 6.8.1, and in accordance with the GOB 6.8.3, we move that the membership of Southridge Community Church in the ONMB Conference be revoked.

Tabitha VandenEnden, Grantham MB - can we hear from Southridge?

Jeff Lockyer, Southridge CC, shared Southridge's perspective. Understand the clarity offered by PFLT and Board that the Confession of Faith (CoF) is not to be treated as disputable matters, and the consequences of being misaligned, but diverge on a few points. CoF feels like it's bearing too much weight, and common relationship and common mission should carry us through a divergence of opinion on shared (or partially shared) beliefs. They do not believe that divergence on one or two shared articles should result in "full removal from the family." Would like to continue in shared mission together regardless of the result of the vote. Their members are 10 to 1 in favour of creating space for full expression of both traditional and affirming views of marriage, and ask for us to respect their position. They love our shared history, identity, relationships, mission, and beliefs. Regardless of how the vote lands, they want, together with ONMB, to be an answer to Jesus' prayer for unity in spite of differences.

Rich Janzen, WMB Church, asked how we understand this in light of our full confession, our centrality of Jesus, our view that community is the centre of our lives, and our call to peace and reconciliation. Cutting off a part of our community because their views make us uncomfortable seems to reflect the world more than Jesus. And we desperately need reconciliation with the LGBTQ+ community who have been harmed by the Church. Wisdom would suggest that we take time to wrestle with why this topic is leading us to live outside of our character as MBs.

Mike VandenEnden, Grantham MB, proposed an amendment to name all 3 locations of Southridge CC on the motion. This amendment was seconded but not passed.

Christine Jantzi, Maple View Mennonite, appreciates the hard work of our Board, and deeply appreciates belonging to this family. Having recently left another denomination they had a long history with, can appreciate the challenge we're facing. And notes that she continues to love and minister together with other nearby churches in her former denomination.

Shelley Campagnola, WMB Church, Question arose about if this vote does not pass, how does that affect our position in the Canadian Conference? Suspension in Ontario = suspension nationally.

Answer: Yes that is possible. CCMBC has the authority to suspend or remove provincial conferences

Shawn Branton, WMB Church. Jesus is not ethically wishy-washy - doesn't condemn the woman caught in adultery, and tells her to go and sin no more. Part of being a covenant church is agreeing to stand in the same space.

Vic Thiessen, Glencairn - we don't know exactly what will play out after this vote. But God knows, so we rest in the promises of God to be with us, even though paths may shift. The Prodigal Son. Wants to bless Southridge for where God is going to take them, and wants to bless what God is going to do in our conference under our current structures.

Wayne Wagler, Maple View Mennonite - Grieved to ask someone to leave, but also rejoicing that we hold to our convictions. Trusts our leadership.

Derek Klumpenhouwer, WMB Church - if both churches are removed, does that automatically remove their credentialing?

Answer: Yes. They can seek credentialing under other denominations. Their registration for marriage would also be removed.

Vishal Rangha, Behta Darya CC - appreciates Mike V's "Abrahamic spirit" (like when he bargained with God for Sodom and Gomorrah). We chose the leadership with our free will, and have given them the responsibility to make decisions on our behalf. This is not easy, but it makes me think of Barnabas and Paul - they disagreed and took different directions. If we have chosen this leadership and trust in them, then we must appreciate their painful, hard work.

Twila Smith, Evergreen Heights CF - the leadership that is in place right now is not the leadership that was in place at the onset of these discussions. Ed Willms is not here. That needs to play a part in the conversation and decision-making process, that the leadership that stands before us is not the leadership that was put in place by our voting members. Does not understand why we would remove those with the most knowledge and understanding of these issues from being part of this conversation.

Point of Information: Parliamentarians clarified that Ed Willms as Executive Director is not a voted upon leader. He is hired by the ONMB Board.

Kevin Bayne, Cornerstone - with a heavy heart, speak in favour of motion. Offer thanks to PFLT and Board for providing clarity. To vote against this motion would put our conference in a precarious spot. Our Confession (COF), while a part of our identity, it is a critical and essential part. Like permission to play - and then we engage in shared mission and shared relationship. We are eager to continue conversation around how can we love LGBTQ+ people. We're eager to have the conversation about how to share the gospel to them and how the life of Christ can be expressed in them. But we've been having the conversation about our position for a decade. We'd like to move beyond that, because it's settled after 2 study conferences and conversations. For us, the questions of sexual ethics as a Christian disciple is a big deal and we stand in alignment with our COF on that issue. And we want to learn to walk in repentance and humility because of the COF is true, it must be good news. How do we put it into practice, in the context of our position. Honour brothers and sisters at Southridge, wishes they didn't make this decision, that they would change their mind, and also wishes them God's blessing.

Mike Dyck, Grantham MB - This vote will not be unanimous. That means this conversation isn't over, and we're not actually settled. It's ok if it's messy. We're in the hands of God and he'll take care of us.

### NOMINATING COMMITTEE REPORT



The members of the Nominating Committee (NC) for 2023/2024 were Tabitha VandenEnden, Bill Stubbs, Terry Shuh and Jeff Martens. Ryan Jantzi participated in some meetings as a non-voting member by virtue of his position as Interim Executive Director. This year there were two (2) openings to be filled on the Board of Directors (BoD) to maintain its current size of eleven (11) members.

According to the conference's General Operating Bylaw (GOB) (Article 8.1) the BoD can range in size from seven (7) to twelve (12) members. After processing all received nominations, the NC recommends the BoD operate with its current size of eleven (11) members for the next year. This year there were also two (2) openings to be filled on the NC. GOB (Article 12.2.1) outlines the NC to consist of at least three (3) members.

The GOB (Article 12.2.2), outlines the mandate of the Nominating Committee is to present a slate of candidates for all elected roles on both the BoD and the NC who have been duly processed and discerned to fill vacancies. As part of the discernment process, each nominee responds to a questionnaire, interviews with the NC and provides two references who are members of an MB church, with at least one from their congregation.

In October of 2023, all MB churches in Ontario were invited to submit nominations for the election of candidates for the BoD and the NC. Additionally, Ryan Jantzi and members of the BoD were proactive in seeking out qualified candidates and following up with previously nominated individuals. The nomination process takes time and prayerful discernment. Potential board members also need to prayerfully consider whether they have the necessary time and resources to accept a nomination. Therefore, starting the nominating process early in the year is important. The NC wants to hear from members and is asking our member churches to begin the discernment process now by prayerfully considering

candidates who could serve on the BoD in 2025. Nominating gifted, qualified and spiritually mature individuals who can serve on the board is one way that our churches collaborate and bless the conference as a whole.

This year, the NC is presenting two (2) new candidates for the Board of Directors and two (2) new candidates for the Nominating Committee who went through the discernment process with the NC and were deemed suitable candidates. You will find their names and personal profiles at the end of this report, along with four (4) existing BoD members and two (2) existing NC members slated for re-election.

The NC would like to thank this year's candidates for their willingness to let their names stand for election. The NC also wishes to thank outgoing board members Darrell Gillespie and Timothy Quek for their time serving on the board as well as outgoing Nominating Committee Member Bill Stubbs for over 11 years of dedicated service.


# 2023 – A year of stability within a year of transition!




### 2023 ONMB Revenue

### THE BOTTOM LINE...

The 2023 ONMB Budget was approved with recognition that we would be in transition and that revenue would be lower. Despite this, we finished 2023 with a **surplus of \$36K**. Church commitments came in **3% higher** than budgeted and an overall **decrease of 7%** over the previous year.

Expenses were **3% higher** than budgeted due to the use of funds from the Emergency Fund (surplus funds set aside for assisting pastors and churches in need). Expenses **decreased by 31%** over the previous year.


We have a new Executive Director!! **Welcome Trevor Seath!** Ryan did a great job as our Interim ED and he is eager to return to his original role as Ministry Director. The ONMB Board and staff have a strong desire to continue to increase the engagement of churches and leaders. In the fall of 2023, a video was distributed from the Board and staff inviting churches to examine their giving and move towards the suggested 5% (if not already there) for One Stream funding.

In anticipation of a positive response, we have increased budgeted revenue from church commitments. We need your support in order to expand our impact and re-invest resources into the opportunities and needs of our churches.


# 2024 Proposed Revenue

### THE BOTTOM LINE...

The proposed 2024 ONMB Budget is being presented as a balanced budget (with a small surplus). We have budgeted for an increase in revenue from church commitments (over 2023 actuals) of 7.5%. Budgeted expenses are 17% higher than 2023 actuals, due to moving from a 2 to a 3 person staff. We believe this sets us up well for the ministry the Lord has for us. Increasing our revenue will realistically take more than one calendar year. Therefore, for the 2024 year, we have decreased our commitment to CCMBC from 30% to 22%. We have had a good conversation with staff and board members of CCMBC to ensure that they understand we remain committed to our national partnership and to express that we anticipate being able to give more than we have promised and to be able to return to our 30-33% target in future years.

#### INDEPENDENT AUDITOR'S REPORT

To the Members of Ontario Conference of M.B. Churches

#### Qualified Opinion

We have audited the financial statements of Ontario Conference of M.B. Churches (the Conference), which comprise the statement of financial position as at December 31, 2023, and the statements of changes in net assets, revenues and expenses and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, except for the possible effects of the matter described in the *Basis for Qualified Opinion* section of our report, the accompanying financial statements present fairly, in all material respects, the financial position of the Conference as at December 31, 2023, and the results of its operations and cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO)

#### Basis for Qualified Opinion

The Conference derives a portion of revenue from Northend Church cash donations, and in common with many charitable organizations, the completeness of which is not susceptible of satisfactory audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the Conference and we were not able to determine whether any adjustments might be necessary to contributions, excess of revenues over expenses, current assets and net assets.

In common with small charities, the Conference expenses tangible capital assets when acquired. The expenses related to tangible capital assets are recorded in the statements of revenues and expenses. This accounting policy is further described in note 2.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Conference in accordance with ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with ASNPO, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Conference's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Conference or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Conference's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to

#### 1. DESCRIPTION OF ORGANIZATION

Ontario Conference of M.B. Churches (the "Conference") serves a constituency of member churches in the Province of Ontario. It provides general denominational oversight and facilitates the operation of joint initiatives and gives guidance to the separately incorporated agencies of the denomination which are operating in the province. The Conference received its Letters Patent as a non-share capital corporation from the Province of Ontario in 1932. As a registered charity under the Income Tax Act, the Conference is exempt from tax on its income.

As part of serving the constituency of churches, the Conference took over the operations of the new **Northend Church** (formerly Fairview M.B. Church) during the fiscal year ending December 31, 2018. These operations continued until January 13, 2021, at which time Northend Church received their charity status. See "Fund Accounting" Note 2, and Notes: 3, and 5 for details.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO).

#### Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

#### Net assets

- a) Internally restricted net assets are funds which have been designated for a specific purpose by the organization's Board of Directors.
- b) Unrestricted net assets comprise the excess of revenue over expenses accumulated by the organization each year, net of transfers, and are available for general purposes.

#### Designated fund exclusions

The Conference is sometimes the conduit for certain designated funds to flow through its accounts to the designated recipient. These flow through amounts are not disclosed in these financial statements, but are recorded in the ultimate recipients' financial statements.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

#### Fund accounting

Ontario Conference of M.B. Churches follows the deferral method of accounting for contributions.

Revenues and expenses related to program delivery and administrative activities are reported in the General Operating Fund.

Revenues and expenses related to program delivery and administrative activities for **Northend Church** are reported separately in their own related fund.

Restricted contributions for operations are deferred and recognized as income in the related fund once they are disbursed.

#### Cash and cash equivalents

The Conference's policy is to present bank balances net of outstanding cheques and deposits under cash and cash equivalents.

#### Capital assets

Capital assets are recorded at a nominal charge. The cost of additions are charged to expenses at the time of purchase. Management has decided to not recognize capital assets and remove the expense in the statements of revenues and expenditures in accordance with ASNFPO. Changing the presentation to capitalize expenditures from operations may reduce useful information to the primary readers of these financial statements as they would now appear on the separate statement of financial position, and not against the budget.

The capital asset related to the acquisition of property was recorded and recognized due to its significant value and mortgage thereon. This property is utilized by the operations of the Northend Church, and consists of land, building, and furnishings. As the Northend Church has obtained individual charitable status, the property has been transferred to the new Church as of April 2022.

#### Contributed services

The operations of the organization depend on both the contribution of time by volunteers and donated materials from various sources. The fair value of donated materials and services cannot be reasonably determined and are therefore not reflected in these financial statements. Certain larger material contributions are recognized at their fair market value.

#### Financial instruments policy

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expensed when incurred.

#### 3. DESCRIPTION OF FUNDS

The General Operating Fund accounts for the Conference's program delivery and administrative activities. This fund reports unrestricted resources and restricted operating grants. \$50,000 is allocated to a separate General Operating Fixed Minimum Fund.

An Emergency Fund of \$25,000 was created out of the Operating Fund on December 31, 2005 to support any church's pastor (or family) in the case of sudden financial curtailment.

The Special Project Fund was established to segregate any special projects outside the normal course of operations.

The **Northend Church Fund** is a new church plant fund (formerly Fairview M.B. Church) operated by the Conference. The new Northend Church registered as a charity on January 13, 2021 and began operations independently of this related fund. Remaining Northend Church Fund assets, net assets, and the statement of revenue and expenses have been disclosed separately to recognize any church activities still operated under the Conference. As at December 31, 2022, the only remaining balances within the Northend Church Fund have been transferred to Northend Church.

#### 4. INVESTMENTS - CANADIAN CONFERENCE

The investment is with the Canadian Conference of Mennonite Brethren Churches earning interest at a base rate of 5% at year end. See note 6 for interest rate risk.

#### 5. RELATED PARTIES TRANSACTIONS

The Conference has transactions with numerous related parties (member churches) or organizations that are funded by the Conference. These financial statements do not determine, disclose or verify external affiliate activities.

2023 charitable contributions of \$0 (2022 - \$116,870) are net payments of received donations to the new Northend Church registered charity.

During 2022 Net transfers of \$111,286 to the Northend Church Fund Net Assets are to the Church, and include the transfer of the Church property and its related mortgage.

#### 6. FINANCIAL INSTRUMENTS

The Conference is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the Conference's risk exposure and concentration as of December 31, 2023.

Interest rate risk

Interest rate risk is the risk that the value of a financial instrument might be adversely affected by a change in the interest rates. In seeking to minimize the risks from interest rate fluctuations, the Conference manages exposure through its normal operating and financing activities. The Conference is exposed to interest rate risk through its investment savings account balance.

Constituency dependency risk

As the Conference serves the member churches, it is dependent on these member churches for financial support.





#### PROVINCIAL FAITH & LIFE TEAM REPORT

#### MANDATE:

The Provincial Faith and Life Team (PFLT) is a standing committee of the Ontario Conference of Mennonite Brethren Churches (ONMB) board, as set forth in the ONMB General Operating Bylaw. Its authority and mandate, as outlined in the bylaw, is to:

- (1) Initiate, study and recommend any matters of faith and life related to the issues of ministry and church life in the Ontario Conference or to the relationship of the Ontario Conference to broader issues in society at large.
- (2) Maintain the centrality of the Confession of Faith and interpret and apply it to all Ontario Conference ministries and programs in a manner consistent with interpretations and practices of the Canadian Conference of Mennonite Brethren Churches and the National Faith and Life Team.
- (3) Administer the processes for both credentialing and de-credentialing individuals for Christian ministry who serve the Member Churches of the Ontario Conference, or who serve in other similar leadership and spiritual functions.

- (4) Maintain the registry with the Ontario office regarding the licensed ministers of the Ontario Conference.
- (5) Give guidance to Member Churches, Associate Churches, and any other organizations using the Confession of Faith in matters of faith and doctrine.
- (6) Appoint one of its committee members to serve on the National Faith and Life Team of the Canadian Conference.
- (7) Assist the Board in discerning new congregations applying for membership in the Ontario Conference.
- (8) Assist the Board in matters of the suspension, revocation or reinstatement of a Member Church.
- (9) Interview individuals to determine their standing as described in the bylaw.

Through these mandated roles, the FLT participates in and collaborates with the National Faith and Life Team (NFLT) to articulate and safeguard Mennonite Brethren theological convictions, and provides discernment and guidance on contemporary issues within the Province of Ontario. This task is accomplished primarily through sustaining our MB confessional foundation, guiding and supporting churches and their leaders, and facilitating the credentialing process for church and ministry leaders.

#### PROVINCIAL & NATIONAL ACCOUNTABILITY:

The PFLT is accountable to the ONMB board, and by extension to the ONMB conference of churches. Each Provincial Faith and Life Team across Canada has a direct relationship to the National Faith and Life Team by appointing one team member as a representative to serve on the NFLT, and to ensure national and provincial coordination and collaboration on Faith & Life Team matters.

# FAITH & LIFE TEAM:

During this past fiscal year, our Ontario PFLT officially met six times in March, May, June, October, November, 2023 and January 2024, through a combination of zoom and in-person meetings, with additional meetings for credentialing interviews, meetings with various church leaders, and preparatory work.

PFLT team members and chair are appointed by the ONMB Board. During this last fiscal year, the following people served as members of PFLT, all of whom are credentialed pastors/leaders within our MB denomination:



#### **CREDENTIALING:**

One of the major PFLT roles is ensuring that our pastors and ministry leaders are credentialed, in order to maintain the centrality of our MB Confession of Faith in the context of ministry leadership and practice, and to ensure that our pastors and leaders in our ONMB family are ethically able and supported in their ministry roles. The credentialing process includes:

- Completing the national Ministry Credentialing Questionnaire or Mentor-Based Credentialing Process
- •interview with two members of the PFLT

- reference checks
- •prayerful discernment and vote by the PFLT as a whole
- •signing the MB Code of Personal and Ministry Ethics
- •attending the National Pastor's Credentialing Orientation (PCO)
- •NEW completing Healthy Leaders Training once every five years (see below)
- •Note: This credentialing process is expected to occur within the first year of a new pastoral assignment, with PCO to be completed within two years of credentialing.

## PROVINCIAL FAITH & LIFE TEAM REPORT

#### **CHURCH WITHDRAWAL:**

It is with sadness we report that in May, 2023, Living Hope Bible Church (formerly Port Rowan MB Church) chose to withdraw their MB membership effective December 31, 2023, due to their stated difference in theological convictions, and their desire to pursue a different vision and direction.

# 2023 TOPICS AND SPECIFIC WORK:

1.ONMB Interim Executive Director - Supporting Ryan Jantzi as the ONMB Interim Executive Director in his role responsibilities with our Ontario churches, ministries, and leaders, in matters of faith and life.

2.Healthy Leaders Training – Working with the Interim Executive Director to establish credentialing training tools to better position healthy leaders and churches in Ontario. A key component of this for 2023 was developing a new ONMB initiative, called Healthy Leaders Training, to be completed by all credentialed leaders once every 5 years, beginning in February, 2024. Knowing that leading God's people can be complex, this training focuses primarily on pastoral vulnerability and power dynamics. Abuse of power can happen in ways we least expect, causing hurt and damage in ways we least intend. Healthy Leaders Training is preventative training, designed to provide healthy ways for our credentialed leaders to lead and guide others in appropriate, Christ-honouring ways.

3.Confessional Integrity - Exploring ways to help our ONMB churches live and model confessional integrity with the MB Confession of Faith on a variety of complex, cultural topics, while still demonstrating Christ's love and grace to all people. 2023 topics: Divorce & remarriage; LGTBQ+; MAID.

4.Revoice Cohort - Exploring through a Revoice Cohort regarding how to guide our leaders and churches in LGBTQ+ care, while remaining true to our Mennonite Brethren convictions.

5.Emergency Pastoral Support Fund - Working with the ONMB Board to update the Emergency Pastoral Support Fund Policy, and applying it to come-alongside a specific situation in restorative and redemptive ways.

6.EQUIP & CCMBC AGM - Participating in our national MB EQUIP conference on the topic of "Why Church, Why MB?" held in Abbotsford, B.C., and engaging with others across Canada for denominational discernment and decision-making.

7. National Faith & Life - Providing input to NFLT regarding work on collaborative national documents, particularly from an Ontario perspective. These are documents that all provincial MB conferences hold in unity across Canada, and seek to implement together as one denomination, but in many different geographical and cultural settings. In 2023, this work primarily included feedback and implementation of the Collaborative National Church Affiliation & Review Policy, the Confession of Faith Amendment Procedure Policy, the Collaborative National Credential Policy, and ongoing review of Confession of Faith wording, focusing on Articles 2, 6 and 7. Initiating dialogue with the NFLT to clarify aspects of the MB Divorce & Remarriage Policy, and the MB position on women in ministry leadership across Canada:

## ORGANIZATIONAL HEALTH TEAM REPORT

#### FIRST FULL YEAR AS OHT

This has been the first full year that the Organizational Health Team (OHT) has been operating since its transition from the old Governance Committee. Much of our work has continued on the same lines as before, assisting churches with their ONCA compliance and drafting policies. We expect to expand our scope as soon as the National Assembly begins to roll out its OHT initiatives. Indications are that these will include systems for assessing and equipping our local churches to measure organizational health and training for our leaders and Boards.

#### **ONCA UPDATE:**

A note for our Lead Pastors and Boards, the deadline for ONCA compliance is October 24th, 2024. If your church has incorporated as a not-for-profit in Ontario and have not started the process of reviewing your bylaws, the time to start is now! Bylaw review takes time, and we highly recommend that you have it reviewed by a lawyer all before the deadline date. The OHT is here to help Boards with that review process. We have gathered several articles that will guide you. Please contact the ONMB Office and we can start that dialogue with you.

#### THE TEAM:

The OHT would like to welcome Trevor Seath as our new Executive Director; we look forward to working with you. This past year we have had a number of people come off the team. We want to say thank you to Noah Grossman, Darrell Gillespie, Brenda Kirkwood, Tanya Janssen and last but by no means least, Ryan Jantzi. Ryan has done an amazing job in his role as Interim Director and will come off the team to focus on his Ministry Director role. The OHT is currently comprised of Trevor Seath E.D., Board Members Brent Kipfer, Doug Valerio, and our newest member Katie Hines from Scott Street Church. Welcome Katie.

#### **POLICY WORK:**

- •We have been working with the PFLT on the Emergency Pastoral Support Fund Policy to update it to fit our new governance structure. This Policy is to be used in the case of an ONMB Pastor, Leader or ONMB Staff member needing emergency financial assistance.
- •The Associate Churches Policy has had a major review this year to align it with the changes in our GOB. The Policy remains a Board policy and will not be voted on at Convention. The main changes are two new categories of Associate Church.
  - •Extended Associate Churches these are Missional Expressions or fellowships that are not currently able to be full members.
  - •Exploratory Associate Churches church plants or existing churches that are new to the ONMB and discerning the possibility of becoming full member churches.

#### **POLICY WORK:**

- •We continue to assist and advise the team that is dedicated to working with Valleyview Manor in preparing them for bless and release.
- •We were able to assist Meadow Brook Church and WMB with their ONCA bylaw reviews.

# 2024 INTERIM NATIONAL DIRECTOR REPORT

It is my privilege to serve as CCMBC's Interim National Director. At the October 2023 National Assembly, we thanked Elton DaSilva for serving our family of churches faithfully for five years and blessed him in his new role as Global Director of ICOMB (International Community of Mennonite Brethren). We look forward to welcoming Cam Stuart as CCMBC's National Director on April 1, 2024. Cam comes into this role with over three decades of MB pastoral leadership and several years of service on our Executive Board. He is passionate about our national vision, our ministries, and our collaboration model involving the six provincial conferences and three member agencies. We thank God for Cam and other leaders stepping into new roles in our MB family across Canada.

Our MB family continues to engage in difficult conversations. Reflecting upon this, I am reminded of two impactful books. In Canoeing the Mountains (2015), the author explores the kind of Christian leadership required "to navigate the uncharted territory of our rapidly changing cultural landscape." In Mission Drift (2014), the authors describe the critical need for organizational leaders to remain "mission true" by exhibiting an intentional, long-term commitment to Christ and the gospel to avoid drifting off course. As leaders who help navigate difficult conversations, we must remember we are serving Jesus, no matter our discomfort (Colossians 3:23-24). We must glorify God in all we say and do, exercise faith (Hebrews 11:6), love sincerely (Romans 12:9), be filled with the Holy Spirit (Ephesians 5:18), and offer ourselves as a living sacrifice (Romans 12:1).

#### 2023 in Review

CCMBC's mission is "To cultivate a community and culture of healthy disciple-making churches and ministries, faithfully joining Jesus in his mission." Our Collaborative Unified Strategic Plan (CUSP) is the shared roadmap for how we believe God has called us to work together toward the fulfillment of CCMBC's mission. We desire to work collaboratively with our six provincial conference partners (viz., AEFMQ, ONMB, MBCM,

SKMB, ABMB, BCMB) and three member organizations (viz., Legacy, MB Seminary, Multiply), moving together in the same direction. We continue to fine-tune our working relationships with our partners and believe this collaborative model is the best path to fulfilling the mission God has called us to. Within the CUSP, there are four strategic priority areas:

The National Faith & Life Team has responsibility for **Spiritual Health** (for an update in this area, see the National Faith & Life Director Report).

The National Ministry Team is working together with MB Seminary in **Leadership Development.** The goal here is to encourage greater ministry effectiveness for existing MB credentialed leaders through the provision and tracking of high-quality ongoing professional development. There is a clear need for the identification, development, and equipping of new disciple-making leaders able to step into existing and anticipated leadership openings in the coming years.

The National Ministry Team is working together with Multiply in **Mission** with the hope that each of our MB churches across Canada can be a "healthy, disciple-making church." This requires a multidimensional approach that embraces evangelism, ongoing disciple-making, and overall church health.

Finally, the National Ministry Team has **Organizational Health** as a strategic priority. The goal is that each provincial conference, each member agency, and each local church would continue to grow toward organizational health by having clear policies, effective conflict resolution methods, skilled HR staff people, and access to outside assistance when best practice requires it. CCMBC and Legacy are working toward this as well by approving a new CCMBC Employee Manual and by moving toward the approval of a new Governance Manual.

In terms of specific CCMBC responsibilities, we hosted our Annual General Meeting on June 8 (via Zoom), and our National Assembly on October 28 in conjunction with Equip 2023. Senior CCMBC employees were present at the ICOMB Summit in May, CanAm meetings



in October, Canadian Council of Anabaptist Leaders (CCAL) meetings, and meetings of the Evangelical Fellowship of Canada (EFC). We continue to provide communications for our Canadian MB family through our website, social media, and the MB Herald Digest.

#### Financial Update

Our seventh organizational value states "We steward resources on God's behalf" which means that we value responsibility, competence, integrity, accountability, and transparency. We anticipate reporting a small surplus for 2023 in part because of a generous one-time estate gift. We continue to progress towards the full repayment of our related party obligation to Legacy that resulted from the restructuring that was required of us five years ago. We continue working with our provincial conference partners to find the best funding model for our collaborative efforts.

#### Looking forward in 2024

While we are thankful for all the positive steps in 2023, we know that we are just beginning to see the fruit of our work together in the four strategic priority areas. We invite you to pray for us and all our partners as we serve together. We invite you to a renewed commitment to your local church that it would be a healthy disciple-making church. We invite you to pray that God would raise new leaders within our MB family who would lead faithfully in this direction as well.

On a personal note, I am thankful for the significant efforts of our Executive Board, the National Ministry Team, the National Faith & Life Team, the directors, and employees of MB Seminary and Multiply, and our provincial partners. I thank the dedicated employees of CCMBC and Legacy for their steadfast commitment to serving our constituents. Through this, we celebrate the signs of God's faithfulness in our MB family. I offer my prayers for God's richest blessings upon all of you in 2024.







# NATIONAL FAITH & LIFE DIRECTOR REPORT FOR 2024 PROVINCIAL CONVENTIONS

#### Mandate

According to the new Collaborative Unified Strategic Plan (CUSP), we as a Conference exist "to cultivate a community and culture of healthy disciple-making churches and ministries, faithfully joining Jesus in his mission." The National Faith and Life Team (NFLT) exists to articulate and safeguard Mennonite Brethren theological convictions, produce theological and pastoral resources, and provide discernment and guidance on current issues. The National Faith and Life Team stewards the Confession of Faith on behalf of the Conference.

#### Activities in 2023

This has been a very full year for me, but I experienced it with much joy because of the excellent National Faith and Life Team members, CCMBC Staff, and those on the National Ministry Team and Executive Board. It feels like all of these individuals are one big team serving the church together. It is a privilege to be part of this with them. I'm thankful also to have worked closely with Elton DaSilva, Carson Samson, Liam Bull, and Kara Friesen. Both Elton and Kara have moved on to other ministries and I wish them God's very best there. They will both be missed. I am thankful to have Jason Krueger in the Interim National Director role and for Cam Stuart who will be stepping in soon as our new National Director. I look forward to what God has for us together!

- Some of the NFLT highlights for 2023 include:
- We produced a monthly "Moments in Prayer" resource that revolved around prayers on the topic of "Holy Spirit—Fill us!"
- We approved the **Collaborative National Church Affiliation and Review Policy** that assists our provincial conference families with clear and shared mutual expectations between local churches and their provincial/national conference. It also provides clarity around processes if these relationships break down.
- We approved the **CCMBC MB Confession of Faith Amendment Procedure Policy** that gives direction related to why and how the Confession of Faith might be amended. It is important that this process if clear to everyone in our family.

- We gave final approval to the "Introduction to the MB Confession of Faith (2023)" which provides greater clarity around the purpose of the CoF and what "affirming" it involves.
- We gave final approval to Article 1: God (Explanatory Notes) and Article 2: Revelation of God (Explanatory Notes) as part of our Confession of Faith Resources Revision Project.
- We gave final approval to the "Revised Credentialing Questionnaire" which requires all prospective leaders seeking credentialing from their provincial MB conference to interact more intentionally with our MB Confession of Faith.
- We expanded on some earlier revision work done by Andrew Dyck to the Liturgical Readings and approved 18 Responsive Worship Readings that correlate with each of the 18 articles in our CoF.
- We created a draft document called "Defining a Healthy Church" to encourage discussion around what a healthy local church looks like (and ultimately how we can measure that and seek ways of increasing church health).
- We partnered with MB Seminary and MBCM to oversee the Pastors Credentialing Orientation
   June 6-8, 2023 at The Meeting Place (Winnipeg)
   with 30 registrants (26 regular and 4 "Alumni").
- We oversaw Equip 2023 (Oct 26-28) at Northview Church (Abbotsford) on the theme Fire and Ashes: Why Church? Why MB? (A Family Conversation). We had about 220 registrants from across Canada, with many extra drop-in attendees for the evening sessions. Equip 2023 concluded with the National Assembly on Saturday morning.
- Besides all of these more formal NFLT involvements, I had the privilege of being the main writer for the newly developed Q&R Corner in the MB Herald Digest which began in April 2023. It provides an opportunity to respond to questions that individuals from across the country have on topics of relevance. I also had the privilege of presenting on "Fire & Ashes: Why Church?" at Equip 2023 (video recordings of most of the Equip plenary presentations are available here).

While we celebrate all the highlights from 2023 (and thank God for so many answered prayers!), we continue to engage around the following items for 2024:

- We want to increase our commitment to prayer, so we have introduced a monthly prayer guide as part of our 2024 Contending in Prayer series. The monthly guide will sent out to all of our MB Herald Digest subscribers via email, as well as published in the MB Herald Digest.
- We are hoping to give significant effort to our **Confession of Faith Resource Revision Project** this year by processing the following: Revised Explanatory Notes for Articles 3, 4, 5, 6, 7, and 9; Living the Confession (FAQs) for Articles 6 and 7. This is a very ambitious timeline.
- We are hoping to have an "approved in principle" DRAFT of a "Loving Well our Trans Neighbours, Friends, and Family" document to assist local churches. We covet your prayers and wisdom for this since no matter what, it will be controversial.
- We have been asked to work on other resources in response to these questions:
  - 1. What should be our response to Medical Assistance in Dying (MAiD) legislation, and individuals in our churches wanting to access MAiD?
  - 2. What should be our response to the Israel-Gaza War?
  - 3. Should we update our resources on divorce and how we respond to divorce within our church families?
  - 4. Should we be clarifying our Women in Ministry Leadership decisions from 2006 and seeking adherence to these decisions across Canada?
- We will be working with MB Seminary and BCMB in hosting the Pastoral Credentialing **Orientation (PCO)** (May 28-30, 2024) in the Fraser Valley of BC.
- We will be doing preliminary planning for Equip 2025.



We have many "gratitude prayers" for what God has done over this past year—in the midst of both the joys and the sorrows. We want to walk into this year with trust, faith, and hope because we worship King Jesus who is bringing his Kingdom to earth as it is in heaven! We want to be filled with the Holy Spirit as we contend in prayer, live out God's Kingdom both individually and corporately, and invite people from all nations to become disciples of Jesus and part of the body of Christ! And may we see more of God's peace on earth become a reality within our own communities and around the world! May 2024 be such a year!

Uganda Vision Trip in November

Doug also went in advance to be part of a training event for African pastors and church leaders.

Ongoing First Nations Ministry

In July, **Derek, BJ,** and **John** traveled to Brazil for an Amazon River trip where they learned about ministry among Indigenous peoples in Brazil, built prayer partnerships, and survived the mosquitos.

New Partnerships in Diaspora Ministry

**Kyla SP** is encouraged by new partnerships developing with churches interested in learning more about reaching Buddhist background diaspora groups in the GTA as they come alongside her in prayer and financial support.

Philip and Robyn Serez Ministry

It is our hope to get each of our partner churches to spend time in person with their workers (whether Ontario-based or overseas) over the next three years!





# Our Family on Mission in 2023

#### SENDING OUT MISSIONARIES

In 2023, **285 MB churches** in the U.S. and Canada were involved in supporting these teams and **79 long-term workers**, sent from North America, served on teams around the world.

#### PARTNERING WITH NATIONALS

In 2023, we continued to encourage nationals in **70 nations**, walking closely with them and connecting them with North American prayer, giving, and missionaries where needed.

#### HELPING DISCIPLES MULTIPLY

In 2023, 668 everyday disciples participated in 13 Mission
Training Programs based in
North America, and thousands more in our global network participated in similar training worldwide.

## **Financial Overview**



Fiscal Year in \$USD: June 2022 - May 2023

For this fiscal year, our Board of Directors authorized us to invest \$550k from our accumulated reserves to further support our expanding global ministry and the IT systems that support it. Our total usage of reserves was \$448k. This anticipated deficit was further offset by better than expected results in our Operating Fund, resulting in a smaller deficit of only \$275K. Last year's comparative numbers reflect significant cost reductions due to COVID as well as unexpected one-time revenues.





We've all felt this way at certain times in our lives and have wrestled with the doubt and discouragement that can come from not seeing progress in the timeframe we wanted. However, God's promises are trustworthy and we can rest in the work that He has started and that He will complete. ## 2024 REPORT TO ONTARIO MB

## **Becoming a Great**

**News People** is a powerful, positive, and challenging invitation for the Ontario Mennonite Brethren to gather around at this year's convention. And it's a great way to express the vision at the heart of the work of C2C Collective. C2C carries forward the vision that was birthed within the MB Church in Canada by helping leaders, churches, and denominations plant churches across the country. The core of our vision is to see healthy leaders starting fruitful churches and we want to live and work in a way that expresses our core values to be gospelcentered, Spirit-led, mission-focused, and kingdomminded.

The last year of ministry in Ontario included meaning-ful steps of progress as well as some challenges. Following through on discernment in prayer and conversation with others, my focus for the year narrowed in on encouraging church planting collaboration among pastors, seasoned church planters, and other ministry leaders in both Ottawa and Toronto. More than ever before, I wanted to ensure that

my ministry encouraged local leaders to work together to make disciples through church planting. Rather than beginning with specific C2C ministry tools and gathering others around our services, I wanted to prioritize encouraging unity, initiative, and collaboration among local leaders and churches. My hope was to encourage a city ministry culture that would support identifying. developing, sending, and supporting church planters.

#### In the Fall of 2022.

I joined an interdenominational team that had already been convened by Ottawa's One Way Ministries (OWM) around a vision for collaboration to find and support church planters. In support of that vision, I personally hosted lunchtime gather-

ings for interested pastors, church planters, and potential church planters throughout the year. We shared meals, joined in worship, and prayed for one another and the needs of the city. A group of twenty gathered consistently including five who were just starting or still preparing for new church planting projects. In May, our whole OWM team hosted a BBQ for church planting couples and were excited to have 50 join us. During that event, we conducted an online survey to identify where leaders wanted help and were able to follow up on the desire some expressed for coaching. In September, we hosted Bill Hogg for Advance Evangelism Training in response to the top training need identified in the May survey.



# C2C collective

## 2024 REPORT TO ONTARIO MB

In December 2022. Mike Sherbino and his brother David led a meeting at Tyndale Seminary in Toronto to explore collaborative strategies for training and church planting. After attending, I invited leaders from my contacts to a follow-up meeting in January. About 60 came together and Mike and David led an interactive gathering where we looked to identify how pastors and leaders could best collaborate to encourage church planting. I found the conversation and feedback harder in Toronto than in Ottawa. Some leaders resisted the idea of starting another new initiative. Others expressed a strong sense of personal isolation and a greater longing for friendship than for a new challenge. Perhaps more than anything, full schedules and Toronto's size presented significant obstacles as I followed up to discern and implement next steps. At the same time, connections between a small number of highly motivated leaders were strengthened and we worked to support one another in offering two relevant training opportunities later in the year.

**Cultivating and sustaining collaboration** among pastors and leaders to support church planting is not easy. Church leaders rightly understand that God has given them an assignment within their own local context and many are unsure it's wise or even appropriate to give significant energy to initiatives outside their local church. Additionally, since many pastors are disconnected, it can be hard to encourage trust when denominations and churches disagree theologically and have significant cultural differences. When it comes to genuine unity in Jesus' Church, I'm convinced that we're completely dependent on God moving

by His Spirit to show us the way. I saw very encouraging steps forward in both Ottawa and Toronto in 2023, and yet the road ahead is long and steep. Help us, Lord!

In addition to pursuing city-based collaboration, my work with C2C was full of lots of one-on-one coaching, church plant task force and board meetings, and a church planter assessment centre that I organized in May for three church planting couples. C2C also supported new churches with financial subsidies, including 8 in Ontario. Overall, 2023 was a full year and I loved being able to support church planters in meaningful ways.

There's no doubt that **faithful lives** of prayer, relational unity, and practical collaboration foster the culture in which God's kingdom thrives and grows. C2C Collective must model, encourage, and guard these foundational dynamics along with others. Since that's true, even as I've moved into my new role with ONMB, I look forward to supporting and extending the vision that remains at the heart of C2C Collective.

# **GOD IS ON THE MOVE!**

This year began like every other year as we asked God to breathe life into our high school campus. The narrative concerning Christians was increasingly negative, and in some cases it was deserved. We were asking God to equip us to build bridges rather than walls, and He answered our prayers! We were longing for our Christian students to live with a responsibility to others, rather than with a perceived authority over others. Through all these prayers, a word was spoken; "organic." Thoughts began to form (on a piece of cardboard taken from the recycling bin), and new vision was birthed! So what does "organic" look like?

The year began with our Grade Retreats and there were close to 300 students involved in our three retreats, as we unpacked the theme "Becoming." We focused on being a community that is attractive to others, praying for the courage to become more like Jesus in our school, so that others - New Nasmtive would come to know Him. As God met us in times of worship, I honestly

thought the floor was going to cave in at Camp Crossroads (may need to look at the floor structure!) Those retreats became a catalyst for some incredible things that are happening on campus and here are a few highlights:

We have committed every Thursday morning in The First 25 (chapel) to prayer. We called students to pray and 138 showed up for the first one! And we've seen 80-90 regularly attending each week. These meetings are happening at 8:15am in the morning, at school, on a weekday! On average, there are 100+ students attending every day during our teaching times. It's been so encouraging to see a new level of spiritual engagement in our community!

We are also hearing stories of multiple Bible studies and prayer groups that are springing up and these are student initiated! There are some groups that have 20-30 students that are meeting outside of school hours, as they seek to grow in their relationship with Jesus! Please keep these "organic" gatherings in your prayers.



Our Life Groups that meet at lunch are booming in the SLC! Driven, for girls, has focused on "Encounters With Jesus." Every Monday and Wednesday, Alicia and Meghan are leading girls in a study on encountering the living God in a public high school! The Foundry for boys, is every Tuesday and Thursday and we've recently studied some big questions; How do we know we're following the right God? If God is so good and powerful, why is there evil in the world?, Does God hear our prayers? and more. During the last month, we studied Galatians, discovering what it means to move from religion, to a living relationship with Jesus Christ. These are incredible opportunities to disciple students in their faith journey and we're so thankful!

Our SLC Team is going to look different in 2024! Alicia Janzen, who has served in the Spiritual Life Centre since 2003, is finishing her time with us on January 31, and moving into an exciting new role! # Mennonite Brethren

In 2023, Ontario MB churches supported MCC through financial donations, material resource donations of comforters, hygiene kits, relief kits and school kits, hosted MCC speakers and accessed and used MCC resources such as the Peace Packet and World Refugee Sunday materials. MB church members volunteered at MCC Thrift Shops and attended MCC events.

#### Grow Hope Niagara Project

MCC supporters, including some MB churches, support MCC's food security programs by sponsoring an acre of land on Larry and Marg Dyck's farm in Niagara for \$400 per acre. The land is farmed each year and the proceeds donated after harvest. The proceeds are matched by the government and go to help end hunger through MCC and Canadian Foodgrains Bank.

In 2023, there was a good stand of soybeans that had ample rain and good growing conditions. It was combined in mid-October and yielded a crop that fetched over \$1,000 per acre for a \$400 investment, a fantastic way for an initial gift to grow and help provide food for people who need it.

After harvest, the field was planted with next year's wheat crop. Many thanks to the Dyck family for all their efforts in managing this field project and we recognize its success depends on their efforts and expertise.

# MCC work around the world with MB partners: Malawi

The Mennonite Brethren Church in Malawi started in 2009 with a location in Dzaleka refugee camp, and now has over 19,000 members around Malawi. The church seeks to support both the spiritual and physical development of communities, ensuring residents' basic needs are met.

Through the MCC Material Resources program, the church receives and distributes much-needed resources, including MCC comforters and dignity, relief, hygiene, infant care and sewing kits.

Women Development Madevic Mama Tailoring Centre provides employment and training opportunities for women in the refugee camp. Mawazo Fatuma, who leads efforts there, says, "Thank you for the sewing kits. The supplies are very helpful. The women in this centre are able to learn tailoring and make a little money."

#### Ukraine

AMBCU distributes humanitarian assistance, including MCC relief kits, blankets, hygiene kits, toothpaste and canned meat.

#### MDS Canada 2023:

## "You brought hope and love to the community"

"You brought hope and love to the community." That's what Amanda McDougall-Merrill, mayor of the Cape Breton Regional Municipality, said about volunteers from Mennonite Disaster Service (MDS) who came to Cape Breton to repair homes damaged by Hurricane Fiona in Cape Breton.

After the storm, which struck on September 24, 2022, people "felt alone and hopeless," she said. "You did more than build walls and fix houses. You brought love here,"

she said. "There are no words that have the capacity to show how grateful we are."

Altogether, 458 volunteers from across Canada provided over 32,000 hours of service for 272 families and community organizations in Cape Breton. This included repairs to 44 houses, 28 new roofs or roof repairs and 179 tree-cutting and cleanup jobs.

Caroline Purnell's daughter, Rosalyn, had her house repaired by MDS volunteers. When it hit, the hurricane damaged the roof of Rosalyn's house, causing rain to leak in every time a new storm came along. Unable to afford repairs, and with a deadline from her insurance company to fix the roof or lose her house insurance, the situation seemed hopeless for the single mother of three boys.

When MDS offered to fix the roof, everything changed, Purnell said. "When you said you would do the repairs, not only were you helping someone with a leaking roof, you were changing the outcome of an entire family's life. I have seen my daughter go from hopelessness and despair to gratitude and hopefulness for her future," she added. What MDS did "was a miraculous answer to prayer and a

source of encouragement to everyone who hears how you answered God's call," she went on to say.

Along with service in Cape Breton, MDS Canada responded to a tornado in Alberta and did other repairs in other provinces. We also offered the Spirit of MDS Fund once again, providing 26 grants worth just over \$137,000 given to churches and organizations across Canada.

The goal of MDS Canada is to restore homes and hope for survivors of natural disasters in Canada and the U.S.

# VOTING REPRESENTATIVES AND CONVENTION MEMBERS

In addition to the single Voting Representative, a Member Church may have one (1) Convention Member for every twenty-five (25) church members or fraction thereof of that Member Church.

Each Associate Church is invited to register their Representatives into membership as Convention Members.

Both the single Voting Representative AND Convention Members are all voting delegates at Convention, each with one vote, all votes are equal.

The Ontario Conference may grant membership to an individual to become a Convention Member who is a member in good standing of a Member Church that is in good standing with the Ontario Conference.

## CONVENTION RULES OF ORDER 2024

We strive for unity and respect, seeking the participation of all assembled, as we discern decisions that shape the future of our conference.

- •Members are invited to respond to the reports and recommendations presented.
- •When wanting to make a comment, please state your name and Church you are representing.
- •Address your comments directly to the moderator. Open dialogue between members is discouraged on the conference floor. Keep your comments brief and limit repeating statements already given by other members.
  •In order to keep things flowing smoothly, each Member may speak up to three times

on any specific issue. For further comments, he/she must await the Moderator's approval, and that will be given only when no other Member wishes to speak.

- •Guests who would like to comment may request to do so with the Moderator.
- •Additional instructions may be provided by the Moderator regarding procedures.
- •The Moderator reserves the right to bring discussion to a close with proper notification.
- •Only Voting Representatives and Convention Members are permitted to vote.
- •In general, Roberts Rules of Order may be used as a guideline during the business sessions.
