"It all started with a baptism."

As one MB periodical states, "It all started with a baptism." This year marks the 500th anniversary of the Anabaptist movement and the Mennonite Brethren are among its descendants. And baptism became the central issue. For those of us who live in Kitchener-Waterloo, this year marks the 100th anniversary of the MB church in Ontario.

But let us jump back to 1860. It was the year the Mennonite Brethren Church was born in what is now Ukraine. There was a sort of "awakening" in the evangelical churches in Germany that made its way to Russia and it influenced the forefathers of the MBs.

There was a yearning for among other things, more personal piety and holiness, water baptism by immersion following faith-inspired conversion, and communion taken reverently, and not as a ritual. Our leaders produced a signed document on January 10, 1860 with 50 charter members.

The religious freedom granted to our forefathers by the Russian royal family did not last, however. As we all know, the reign of the Russian monarchs came to a violent end at the end of World War One and what became the Russian or Bolshevik Revolution - 1917-1921. Mennonites who were given religious freedom, economic opportunity, and exemption from military service were obviously not interested in the Bolshevik or Communist agenda - and very quickly became among the first of its millions of victims.

For those forced to leave, the city of Kitchener was where some of them came. As you may know, the story of KMB church really begins way back on July 18, 1924, when a large group of German speaking immigrants from the Ukraine in southern Russia stepped off the train at the Waterloo station, carrying what was left of their worldly goods. Because of revolution, anarchy, famine and war, they arrived landless, homeless and grieving the tragic deaths of family and friends. From the Erb Street Mennonite Church, a few blocks away, these tired, dispossessed travelers were assigned to the waiting Swiss Mennonite farmers who had generously agreed to house them.


Some immigrants of shared Mennonite Brethren background soon gravitated to each other. They regularly gathered together in various homes in the St Jacobs and Baden area for worship, mutual comfort and encouragement. They had brought their well-used German bibles and hymn books with them. Pastors within the group provided spiritual leadership. Soon, the group solidified and decided to formally become a church. On May 25,1925, eighteen signatories signed the articles of organization. They called themselves the Molotschna Mennonite Brethren Church, named after one of their largest colonies in southern Russia, Later. the name was changed to the Mennonite Brethren Church of Kitchener; then Kitchener MB church.

So this is how MB conferences begin... come to the ONMB conference on February 21st to hear the rest of the story.

All of us are keenly interested in uncovering every way in which we can function in unity under a single God-given purpose to continue catalyzing and supporting a dynamic and fruitful expression of God's kingdom alongside all of you.

Also, I'm inspired by the ways God is working so dynamically in the ministry of Camp Crossroads. And it was a joy to witness the launch of a new expression of partnership between MB Seminary and Ontario as WMB in Kitchener Waterloo became the school's latest Teaching Church location.



Jesus has led us by His Spirit in 2024. We've heard four invitations from the Lord that have been affirmed in both formal and informal conversations among our leaders. God is calling us to pray first, move together, join in globally, and make disciples.

A simple phrase connected to each has been helpful in providing more clarity:

- **Pray First** entrusting the future to God's power, not our own.
- **Move Together** collaborating in mission regionally for Jesus' glory.

- Make Disciples inviting people to follow Jesus no matter what.




A new chapter in our shared life of prayer was sparked at our 2024 Pastors & Leaders Retreat at Camp Crossroads May 5-7. Derek Parenteau shared a plea from God for ONMB from John 21:1-14 where we read about Jesus instructing his disciples to "cast (their) net on the right side of the boat" (v.6). God gave us a picture in that story of the choice we all have – we can work in our own strength and see nothing of the harvest God has for us or we can humbly, even foolishly, trust His leadership and experience what only He can do for us.



A primary response following this time of hearing from God has been to cultivate a growing response of faith-filled prayer for a move of the Holy Spirit to bring in a God-sized kingdom harvest in our land. You can hear some of the early processing of this response on the Jesus Stories podcast episode "A Plea for Ontario" that was published May 27, 2024.

We moved forward in prayer as leaders and members from our churches gathered on September 10th at Mountain Park Church in Niagara Falls for a day-long Prayer Summit. Since then, two 4-week Online Prayer Ministry Training cohorts have gathered to learn and pray. Alongside these responses, several of us representing each of the regions where MB churches are ministering have been discerning how we can work together as a team of prayer catalyzers for Ontario.





Ontario is a big place, and our Mennonite Brethren family is sprinkled across the province. While we're spread out, we know that God has brought us together into a shared kingdom story. Part of growing into all that God has for us depends on practically figuring out how to serve together in unity. Thankfully, the opportunity is right in front of us since we are not randomly dispersed but form into 6 regional clusters.

Here's a list of those regions and the churches & ministries within them:



- Essex Southpoint Community Church and Meadowbrook Community Church
- Central West Kingsfield Zurich Mennonite Church, Maple View Mennonite Church, Evergreen Heights Christian Fellowship, Glencairn Church, and WMB Church, Belmont Village Church
- Niagara St. Ann's Community Church, Grantham Mennonite Brethren Church, Northend Church, Scott Street Church, Cornerstone Community Church, and Mountain Park Church
- Georgian Bay Christian Fellowship Chapel, Rugged Tree, and Camp Crossroads
- **GTA** Behta Darya Community Church, New Life Christian Church, Life Point Fellowship, Restoration Place, Jesus Network, and Kyla Sinclair-Peters' mission.
- Ottawa Manotick Community Church, The Gathering, Bytown Community Church, Southeast City Church, and Darren Milley's Power Serve mission.

We believe that next steps of mission through disciple making, church planting, and church reignitions will be best discerned and supported as churches and ministries in these regions come together in practical collaboration with support from our ONMB staff team. We are praying for new leaders and fresh vision to rise up in each of these six regions and for the leaders, churches, and ministry partners in those places to discover ways to collectively support the new things God invites them to do.

There are different opportunities and challenges in each of our regions. We should not expect that the next steps of collaboration in God's mission will be the same across these different contexts. Instead, the exciting opportunity is for churches to build trust, listening well to one another and to God and to stand ready in expectation that King Jesus has a plan for multiplied kingdom impact that is waiting to be uncovered.



While the Church in North America is often perceived as a source of resourcing and support for our brothers and sisters around the world, many here are both convicted and encouraged by a growing appreciation for how much we need to learn from the global Church.

We are heavy-laden with resources in Canada. Our minds, browsers, and bookshelves are crowded with strategies and models. Just about every conceivable ministry and mission concept already has numerous resources standing by to support it. Meanwhile, the church is thriving outside the west where Christians face many challenges without most of the resources to which we're accustomed.

Dynamic kingdom partnerships between our churches and churches globally is the goal. To get there, though, it's urgent for us to embrace our role as learners, listeners, and apprentices. We have so much to learn about sacrifice, suffering, Holy Spirit dependence, prayer, faith, and bold witness (to name a few) from our sisters and brothers in the global Church.

We're taking an important step forward in this as a small team of us from Ontario including ONMB board members and staff together with Derek Parenteau from Multiply will visit in Brazil in April. We're keen to learn from MB church and mission leaders there and discern how God's dynamic work in that part of our global MB family can inform and strengthen our vision for how He can work in Ontario.

No call from Jesus is more laden with potential than His commission to reach the nations by making more disciples. None of us would be here today unless generations of Christians had stepped into the adventure of teaching others to trust and obey Jesus. And yet, so many of us in all kinds of roles and positions throughout the Church feel inadequate and anxious about walking alongside another person so that they can come to know and trust Christ.

Along with our whole national family, we're convinced that God wants us to, "cultivate a community and culture of healthy disciple-making churches and ministries, faithfully joining Jesus in his mission." That's our mission as the MB Church in Canada. And so, as we journey, our board and staff are committed wholeheartedly to celebrating, strengthening, and supporting our disciple making capacity so that we grow in this way of living as Jesus' people.





Please let me be a bit blunt as I end: sacrificial unity is the only path into all that God can do with a family of churches like ours. That's why I'm so encouraged by every evidence of deeper unity and shared purpose among us.

An essential part of a part of the Mennonite Brethren story in Canada is embracing, whether individually and as churches, that it's God who has brought us together. Our life together as a diverse collection of churches is a gift Jesus is fashioning as He's building His Church. Pursuing unity and shared sacrifice in God's mission is non-negotiable if we're going to grow up into all we can become by God's grace.

We need each part of our Ontario MB family engaged in this story. Let's dig deep joyfully! Let's step forward boldly, relying on the goodness, faithfulness, and power of God. Let's invest our time, our abilities, and our resources into this shared ONMB story for Jesus' glory!

Ministry Director Report Ryan Jantzi



It is clear to me that God was leading ONMB forward through 2024. The Holy Spirit was revealing our path forward in a way that felt unforced and patiently directed by him. As our new Executive Director, Trevor Seath, led through various conversations, God would weave together a few more threads or reveal a new window to what was next. I can confidently say that God, by His Spirit, is with us and blessing us. May it be toward the end of multiplying disciples together!

Settling in with Trevor this year has been a joy. I feel that we work well together with complementary gifts, passions and perspectives. He, Kristi Lee and I have settled into a good team dynamic. The opportunity to pass the baton to him and to grow in trust with his leadership has been a blessing. I believe the vision God is revealing through Trevor and our Board at this time is in continuation with the work He's been doing with ONMB the last few years.

The following are my primary areas of responsibility as a Ministry Director:

Faith & Life

Jacob Nuh was hired as the new Lead Pastor with New Life Christian Church (NLCC) in Scarborough. This follows one year of excellent ministry by Jacob Birch as a transitional pastor. Jacob Nuh previously pastored New Living Church, an ONMB church planted in 2009 in North York. New Living Church has closed, and the people have joined him at NLCC. We now have zero Lead Pastor openings across ONMB. Praise God!

Sadly, I walked with The Well in Dartmouth, NS as they processed the resignation of planting

pastor Adam Greeley, and discerned God was leading them to close the church after 13 years of ministry. This work was on behalf of CCMBC National Director, Cam Stuart.

Please see the Provincial Faith & Life Team report by Karen West for an account of this team's activity. This includes reference to the National Faith and Life Team on which I also serve.

I am pleased to report the successful completion of a one-day Healthy Leaders Training workshop by our credentialed leaders in February 2024. This training will be a core requirement for credentialed pastors every five years. The initiation of the Taylor Johnson Temperament Analysis (TJTA) included in the credentialing of all Lead Pastors was also completed. This is a tool for helping us hire emotionally healthy leaders and direct our leaders on a path toward health. We've also developed a pathway for Pastoral Leadership Transitions in our churches. I'm excited to walk with our churches through this critical time in a clear, mapped-out way. In 2024 I completed the Basic Ministry Training offering with the Transitional Leaders Network to better assist churches in this realm.

Join us in Winnipeg this fall for EQUIP as MBs a cross Canada seek to grow together. Our theme is The Gospel, Peacemaking and the Kingdom.

Leadership Development



Leadership Development is the area I work most closely with Trevor and I think he's done a great job of investing in our pastors, primarily through a call to deeper prayer across ONMB culture, as seen in our fall Prayer Summit.

In early 2025 I received Ordination as a pastor from ONMB and Maple View Church, following a discernment process. Ordination is a practice that MBs across Canada have been encouraged to re-engage as means of discerning, blessing, anointing and laying hands on emerging pastoral leaders. Would your church consider this empowering practice for pastors in your context?





My greatest joy in this role is connecting with our excellent group of pastors and leaders to listen, encourage and pray together, spurring them along in faithful and fruitful ministry.

God has blessed ONMB with many great disciple makers who love God and others deeply. I'm excited to see what 2025 holds for ONMB.

I believe that 2024, with Trevor at the helm was a good first step with God into the future he's inviting us toward.

Over the last year, God has drawn us together in unity, focus, a shared identity, and a sense of calling. 9. WORSHIP SONG AND WELCOME:

Kristi, Trevor, and Ryan welcomed everyone and opened in prayer. We joined in worship through singing "God of Abraham", "King of Kings" and "Take My Life and Let it Be"

10. Commissioning Trevor Seath:

Michelle Knowles and Jeff Jantzi introduced Trevor. Together we as a community and Trevor himself made commitments to each other and to God. We then prayed a blessing over Trevor.

11. Opening Address:

Trevor Seath envisioned us as a Great News people who can build each other up, reach real needs in our communities, province and country, and learn from the global church.

12. Call to Order:

Doug Valerio and Michelle Knowles gave instructions re: voting and asking questions. Many of the motions that will be made today have corresponding breakout sessions to provide more information and space to ask questions, as well as share about opportunities on the horizon.

13. Quorum:

We have 2 of 4 associate churches represented. We have 21 out of 23 member churches represented. We have 97 Convention Members and 35 guests, meaning there are 132 people with us today.

14. Reports and Motions:

MOTION C24-1 MOVED, SECONDED and CARRIED that JP Hayashida (WMB), Tracy Lepp (South Point Community Church), AND Ed Korschewitz (Grace MB) be approved as parliamentarians.

AND THAT Christine Hiebert (Cornerstone), Tamille Richardson (Evergreen Heights), Renee Serez (WMB Church) and Natasha Baines (Manotick) be approved as ballot counters.

MOTION C24-2 MOVED, SECONDED and CARRIED that the agenda be accepted as presented.

MOTION C24-3 MOVED, SECONDED and CARRIED that we receive the committee and board reports as distributed in the advance in the Convention Book.

MOTION C24-4 MOVED, SECONDED, and TABLED that the minutes from Convention 2023, as presented in the Convention Book, be approved.

Discussion:

Michael VandenEnden, Grantham MB, proposed an amendment to the 2023 Convention minutes, requesting to add more information to the record of discussion for motion C23-15: first to provide a more detailed record of his proposed amendment to motion C23-15, and second to add in comments he had made of which there was no written record.

After consultation with the parliamentarians, it was decided to make some amendments to the draft minutes and table the motion for approval in the afternoon.



15. Board Chair Report:

As we've navigated through some difficult decisions last year, we are grateful for the stories of how our faithful God has been moving across our province among our churches.

Grace MB Church and Radiant City Church have decided to form a new congregation called Belmont Village Church. Brent Kipfer offered a prayer of blessing and encouragement over Grace MB and its members.

Michelle thanked the ONMB Board and Nominating Committee.

Michelle called up Ryan and Kristi to honour them for their open-handed, gracious service. They have both served with excellence. Doug prayed a blessing over them.

16. Interim Executive Director Report:

Ryan is grateful for the opportunity to serve and strengthen the ONMB churches. He encouraged us to continue to work on making our churches safe, welcoming spaces, while holding fast to our convictions as we graciously grow in our relationship with 2SLGBTQ+ people.

Life Point Fellowship and Manotick Community Church Mike Dale and Doug Valerio

Doug: Manotick Community Church has boldly stepped out in faith and seen God provide for their needs as they've been able to better reach their growing community in a relevant way.

Mike: Life Point was deeply impacted by Covid, resulting in the loss of their building in 2023. Their senior pastor retired in 2022 with only 10-15 people remaining in the congregation. Mike and a former student from his youth group built up a core group of people (half of whom are in their 20s) and in June of 2023 they reopened their doors with an influx of at least 20 new people attending.

Ryan: Let's honour Mike as he's raising up young people and passing the baton. Please keep on praying for Life Point and Manotick, that more people would know Jesus through them.

19. Afternoon Session:

MOTION C24-4 MOVED, SECONDED, and APPROVED that the minutes from Convention 2023, as amended, be approved.

The amendment that was made to the Convention 2023 minutes was the addition of the following information to the record of discussion for motion C23-15:

Michael VandenEnden, Grantham MB - Given that Southridge Community Church is three distinct congregations which includes Vineland, the oldest MB congregation in Niagara, he would like to amend the motion to name all 3 locations: Glenridge, Welland, and Vineland. This amendment was not approved.

Michael VandenEnden, Grantham MB - He believes that some of the largest churches in ONMB have



indicated that their willingness to remain part of ONMB hinges on this decision and the direction it indicates ONMB is heading.

Discussion on the amended minutes:

Michael VandenEnden, Grantham MB remarked that the proposed revision to the 2023 minutes did not report specifically what he understood about some of the largest churches in ONMB threatening to leave if Southridge Community Church was not removed. He warned that we should not be too eager to edit history and asserted that what he had said should be recorded in the 2023 minutes in detail.

Michelle expressed appreciation for Michael's candid comments. She also noted that comments and questions have all been recorded in summary form in the minutes. Since the minutes are not a word-for-word record in general, Michelle asserted that the proposed revisions are in keeping with the other recorded comments.

Jordan Duerrstein, Scott Street MB Church expressed he was glad that a more detailed record of Michael's proposed amendment to the 2023 motion to remove Southridge Community Church was recorded in the proposed revision to the minutes. Jordan asserted that documentation is important, so if it had just said "Southridge" it would be erasing part of the dynamic at play.

Michelle commented that the dialogue and conversation is appreciated since we want to process these matters well as a family.





Looking Back...

We have completed our first year with our **new Executive Director**, **Trevor Seath**. **Ryan Jantzi** returned to his original role as Ministry Director and **Kristi Lee's** role was redefined (Operations & Communications Manager), to accurately reflect how she serves ONMB.


While we need to close a gap to achieve a balanced budget, we saw encouraging progress in 2024. Half our churches were able to increase their financial contribution to ONMB last year! Our board remains confident that once all churches are able to contribute 5% of their budget, as indicated the ONMB Family Covenant (2020), we'll be in a healthy and sustainable financial position.



The Bottom Line...

The 2024 ONMB Budget was approved with recognition that we needed to increase our revenue in order to support our mission to cultivate a community and culture of healthy disciple-making churches and ministries, faithfully joining Jesus in His mission.

We finished 2024 with a **deficit of \$21K** in operations. Church contributions came in **8% lower** than budgeted and an **overall decrease of 0.7%** over the previous year. Operating expenses were **2% lower** than budgeted. Still, expenses increased by **14%** over the previous year, which was anticipated (and budgeted) because of our return to 3 staff.






Looking Ahead...

The ONMB Board and staff continue to have a strong desire to **increase the engagement of churches and leaders.** Our decision to change the format of our annual gathering for 2025 is one example of new initiatives in this area. We invite churches to examine their giving and move towards the requested 5% (if not already there) for One Stream funding. For 2025, we have **increased** budgeted revenue from church contributions by **5% over last year's giving**, which reflects only a 0.2% increase over what we anticipate church giving to be, based on some direct conversations, as well as estimates. **We need your support in order to expand our impact and invest resources into the opportunities and needs of our churches.**

The Bottom Line...

The proposed **2025 ONMB Budget** is being presented as a **deficit budget**. In operations, we have budgeted for an **increase in revenue** from church contributions (over 2024 actuals) of **5%**. Budgeted expenses are **5% higher** than 2024 actuals, reflecting increases in fixed costs and cost of living. Last year we noted that increasing our revenue would realistically take more than one calendar year, and we are trusting that we can get there by the end of 2025. For the 2025 year, we have **increased** our commitment to **CCMBC from 22% to 26%**. We remain committed to our national partnership of **30-33%** under One Stream funding, as we invite churches to live into this as well.

INDEPENDENT PRACTITIONER'S REVIEW ENGAGEMENT REPORT

To the Members of Ontario Conference of M.B. Churches

We have reviewed the accompanying financial statements of Ontario Conference of M.B. Churches (the Conference) that comprise the statement of financial position as at December 31, 2024, and the statements of changes in net assets, revenues and expenditures and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO), and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying financial statements based on our review. We conducted our review in accordance with Canadian generally accepted standards for review engagements, which require us to comply with relevant ethical requirements.

A review of financial statements in accordance with Canadian generally accepted standards for review engagements is a limited assurance engagement. The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less in extent than, and vary in nature from, those performed in an audit conducted in accordance with Canadian generally accepted auditing standards. Accordingly, we do not express an audit opinion on these financial statements.

Basis for Qualified Conclusion

In common with many not-for-profit organizations, the Conference derives revenue from donations, the completeness of which is not susceptible to us obtaining evidence we considered necessary for the purpose of the review. Accordingly, the evidence obtained of these revenues was limited to the amounts recorded in the records of the Conference. Therefore, we were not able to determine whether any adjustments might be necessary to donations, excess of revenues over expenditures, and cash flows from operations for the year ended December 31, 2024, current assets and net assets as at December 31, 2024.

Qualified Conclusion

Based on our review, except for the possible effects of the matter described in the *Basis for Qualified Conclusion* paragraph, nothing has come to our attention that causes us to believe that the financial statements do not present fairly, in all material respects, the financial position of Ontario Conference of M.B. Churches as at December 31, 2024, and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO)

1. DESCRIPTION OF ORGANIZATION

Ontario Conference of M.B. Churches (the "Conference") serves a constituency of member churches in the Province of Ontario. It provides general denominational oversight and facilitates the operation of joint initiatives and gives guidance to the separately incorporated agencies of the denomination which are operating in the province. The Conference received its Letters Patent as a non-share capital corporation from the Province of Ontario in 1932. As a registered charity under the Income Tax Act, the Conference is exempt from tax on its income.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO).

Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

Net assets

- a) Internally restricted net assets are funds which have been designated for a specific purpose by the organization's Board of Directors.
- b) Unrestricted net assets comprise the excess of revenue over expenses accumulated by the organization each year, net of transfers, and are available for general purposes.

Designated fund exclusions

The Conference is sometimes the conduit for certain designated funds to flow through its accounts to the designated recipient. These flow through amounts are not disclosed in these financial statements, but are recorded in the ultimate recipients' financial statements.

Fund accounting

Ontario Conference of M.B. Churches follows the deferral method of accounting for contributions.

Revenues and expenses related to program delivery and administrative activities are reported in the General Operating Fund.

Restricted contributions for operations are deferred and recognized as income in the related fund once they are disbursed.

Cash and cash equivalents

Capital assets

The cost of additions are charged to expenses at the time of purchase. Management has decided to not recognize capital assets and to record the expense in the statements of revenues and expenditures in accordance with ASNPO. Changing the presentation to capitalize expenditures from operations may reduce useful information to the primary readers of these financial statements as they would now appear on the separate statement of financial position, and not against the budget.

Contributed services

The operations of the organization depend on both the contribution of time by volunteers and donated materials from various sources. The fair value of donated materials and services cannot be reasonably determined and are therefore not reflected in these financial statements. Certain larger material contributions are recognized at their fair market value.

Financial instruments policy

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expensed when incurred.

3. DESCRIPTION OF FUNDS

The General Operating Fund accounts for the Conference's program delivery and administrative activities. This fund reports unrestricted resources and restricted operating grants. \$50,000 is allocated to a separate General Operating Fixed Minimum Fund.

An Emergency Fund of \$25,000 was created out of the General Operating Fund on December 31, 2005 to support any church's pastor (or family) in the case of sudden financial curtailment. As of December 31, 2024, \$1,711 of the fund has been used.

The Missional Expressions Fund was established to segregate any special projects outside the normal course of operations.

4. INVESTMENTS - CANADIAN CONFERENCE

The investment is with the Canadian Conference of Mennonite Brethren Churches earning interest at a base rate of 3.5% at year end. See note 6 for interest rate risk.

5. RELATED PARTIES TRANSACTIONS

The Conference has transactions with numerous related parties (member churches) or organizations that are funded by the Conference. These financial statements do not determine, disclose or verify external affiliate activities.

6. FINANCIAL INSTRUMENTS

The Conference is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the Conference's risk exposure and concentration as of December 31, 2024. Unless otherwise noted, the risks and management thereof have not changed in the past year.

Interest rate risk

Interest rate risk is the risk that the value of a financial instrument might be adversely affected by a change in the interest rates. In seeking to minimize the risks from interest rate fluctuations, the Conference manages exposure through its normal operating and financing activities. The Conference is exposed to interest rate risk through its investment savings account balance.

Constituency dependency risk

As the Conference serves the member churches, it is dependent on these member churches for financial support.

7. COMPARATIVE FIGURES

Some of the comparative figures have been reclassified to conform to the current year's presentation.

Y'Elshaday Baraki & Christlike Church – Y'Elshaday serves as a church planting apprentice on staff with WMB Church, in partnership with the churches of our Central West region. God has given him a vision for a multicultural church in Kitchener-Waterloo. Currently, Y'Elshaday leads a weekly Bible Study group of approx. 70 young adults, mostly from Ethiopian and Eritrean origin. The hope is to officially launch the church in late 2025 or 2026.

Southeast City Church with David Hood and **Bytown Community Church** with Dan Chook Reid continue to make progress in maturing to be healthy, multiplying church communities. God is clearly at work in these communities!

Church Plants:




Matthew and Heather Houle – Matt joined Southeast City Church as a church planting apprentice in Spring 2024, to discern a call from God to plant a church in Carleton Place. However, the apprenticeship came to an end in the fall as they sensed God leading in a different direction.

Re-Ignitions:

We have no Re-Ignitions to report at this time. We invite our churches to consider struggling churches around you where God might lead you to reignite Gospel witness and the life and mission of His people in that place.

Raising Up Leaders:

We're asking God to raise a movement of leaders for new Missional Expressions and also everyday missionaries. We have two upcoming opportunities toward this end.





- Missional Expressions Experiment Grant Gather a group of young adults to experiment with engaging people with the Gospel. Two successful applicants will receive a grant of \$1000 to assist with experiment expenses. Contact Ryan Jantzi for full details.
- Antioch Mission School Nasser al'Qahtani will lead this training event in Toronto, May 31-June 3. We're looking to empower everyday missionaries. This is an event for regular people, not primarily pastors or church leaders.

We need our churches' help in identifying, blessing and raising up those who have calling and gifting for leading in church planting and new disciple-making initiatives.

In Spring 2025 I will communicate more in terms of strategy and a discernment pathway for Missional Expressions. We invite each of our six ONMB Regions to collaborate in the work of launching new Missional Expressions, empowered by the Holy Spirit.

2025 Provincial Faith & Life Team Report Karen West, Chair

Mandate:

The Provincial Faith and Life Team (PFLT) is a standing committee of the Ontario Conference of Mennonite Brethren Churches (ONMB) board, as set forth in the ONMB General Operating Bylaw. Its authority and mandate, as outlined in the bylaw, is to:

- (1) Initiate, study and recommend any matters of faith and life related to the issues of ministry and church life in the Ontario Conference or to the relationship of the Ontario Conference to broader issues in society at large.
- (2) Maintain the centrality of the Confession of Faith and interpret and apply it to all Ontario Conference ministries and programs in a manner consistent with interpretations and practices of the Canadian Conference of Mennonite Brethren Churches and the National Faith and Life Team.
- (3) Administer the processes for both credentialing and de-credentialing individuals for Christian ministry who serve the Member Churches of the Ontario Conference, or who serve in other similar leadership and spiritual functions.
- (4) Maintain the registry with the Ontario office regarding the licensed ministers of the Ontario Conference.
- (5) Give guidance to Member Churches, Associate Churches, and any other organizations using the Confession of Faith in matters of faith and doctrine.
- (6) Appoint one of its committee members to serve on the National Faith and Life Team of the Canadian Conference.
- (7) Assist the Board in discerning new congregations applying for membership in the Ontario Conference.
- (8) Assist the Board in matters of the suspension, revocation or reinstatement of a Member Church.
- (9) Interview individuals to determine their standing as described in the bylaw.

Through these mandated roles, the FLT participates in and collaborates with the National Faith and Life Team (NFLT) to articulate and safeguard Mennonite Brethren theological convictions, and provides discernment and guidance on contemporary issues within the Province of Ontario. This task is accomplished primarily through sustaining our MB confessional foundation, guiding and supporting churches and their leaders, and facilitating the credentialing process for church and ministry leaders.


Provincial & National Accountability:

The PFLT is accountable to the ONMB board, and by extension to the ONMB conference of churches. Each Provincial Faith and Life Team across Canada has a direct relationship to the National Faith and Life Team by appointing one team member as a representative to serve on the NFLT, and to ensure national and provincial coordination and collaboration on Faith & Life Team matters.

Faith & Life Team:

During this past fiscal year, our Ontario PFLT officially met six times in March, May, June, September, December, 2024 and January 2025, through a combination of zoom and in-person meetings, with extended times for credentialing interviews on May 21 and December 3. Members of our PFLT also engaged in meetings with various church leaders regarding a number of different topics.

The PFLT team members and chair are appointed by the ONMB Board. During this last fiscal year, the following people served as members of PFLT, all of whom are credentialed pastors/leaders within our MB denomination: (Left to Right, Top to Bottom)

Thanks also goes out to Bill Stubbs in volunteering to track all our marriage licensing, as part of our credentialing process. This year, Bill has decided to step down from this role with PFLT. We are grateful for his support over the last 12 years.

Credentialing:

One of the major PFLT roles is ensuring that our pastors and ministry leaders are credentialed, in order to maintain the centrality of our MB Confession of Faith in the context of ministry leadership and practice, and to ensure that our pastors and leaders in our ONMB family are ethically able and supported in their ministry roles. The credentialing process includes:

- Completing the national Ministry Credentialing Questionnaire or Mentor-Based Credentialing Process
- being interviewed by two members of the PFLT
- reference checks
- prayerful discernment and vote by the PFLT as a whole
- signing the MB Code of Personal and Ministry Ethics
- attending the National Pastor's Credentialing Orientation (PCO)
- completing Healthy Leaders Training once every five years
- Note: This credentialing process is expected to occur within the first year of a new pastoral assignment, with PCO to be completed within two years of credentialing.

Church Memberships:

The PFLT is recommending Belmont Village Church to the ONMB Board for an AGM resolution to be received as an Associate Church Member. This designation begins a process of intentionally exploring the possibility of a membership relationship, for a future vote.

2024 Topics and Specific Work:

- **1. ONMB Ministry Director** Supporting Ryan Jantzi as the ONMB Ministry Director in his role responsibilities with our Ontario churches, ministries, and leaders, in matters of faith and life. At the request of Ryan's home church, Maple View Mennonite Church, we are pleased to announce that Ryan was ordained with our ONMB Conference in January, 2025.
- 2. Healthy Leaders Training Our Pastor/Leaders' Day held in February 2024 focused on a new initiative called Healthy Leaders Training. This event was strongly attended and well received as a step towards establishing regular credentialing training tools to better position healthy leaders and churches in Ontario. Knowing that leading God's people can be complex, this training focuses primarily on pastoral vulnerability and power dynamics. Abuse of power can happen in ways we least expect, causing hurt and damage in ways we least intend. Healthy Leaders Training is preventative training, designed to provide healthy ways for our credentialed leaders to lead and guide others in appropriate, Christ-honouring ways.

- **3. Confessional Integrity** Exploring ways to help our ONMB churches live and model confessional integrity with the MB Confession of Faith on a variety of complex, cultural topics, while still demonstrating Christ's love and grace to all people. 2024 topics: Divorce & remarriage; LGTBQ+; MAID; Loving Well Our Trans Neighbours, Friends and Family.
- **4. National Faith & Life** Providing input to NFLT regarding work on collaborative national documents, particularly from an Ontario perspective. These are documents that all provincial MB conferences hold in unity across Canada, and seek to implement together as one denomination, but in many different geographical and cultural settings. In 2024, this work primarily included Collaborative National Church Affiliation & Review Policy, the Growing as a Healthy Leader process, and ongoing review of Confession of Faith wording. Initiating dialogue with the NFLT to clarify aspects of the MB Divorce & Remarriage Policy, and the MB position on women in ministry leadership across Canada has continued to unfold.



Through a series of God arranged events, during the Fall of 2021, two churches began to meet together on Sundays and in the Fall of 2022 followed God's direction to become one group of people who would be better together, caring for each other, and reaching out to the people of KW. And Belmont Village Church was born! The merger became a new legal entity in the Fall of 2024. (See BVC Building Pic)

BVC wants to be a church that does life around the gospel. Daily rhythms as individuals and as a church community are being framed around a walk with Jesus that embodies the belief that God's good news leads us into mission with others for others.

BVC invites people to participate in missional families that have a particular focus toward specific

people or people groups in the KW community. A few examples: Through participation in a Learn English Make Friends (ESL) Program, and a House of Friendship Food Program, both located at a nearby Community Centre, BVC is intentional about hosting bridging events to foster these new relationships with people. Events such as Community Christmas Dinners, Lenten Lunches, Board Games Cafés, and a Free Community Garage Sale have created a 'come and see' posture with many new friends. We are excited about the vision God is growing for BVC to be a praying church of intercultural and multi-generational followers of Jesus, neighbouring and on mission both individually and together in community. There's an exciting buzz in the church that God has BVC on a path to build and thrive in 2025 and beyond.





*In 2001, Grace Mennonite Brethren Church began as a group of 17 families who loved God, cared for each other, and wanted to see the KW community meet and follow Jesus.

*In 2012, Radiant City Church began as a group of 31 people who loved God and many of whom moved into specific under-resourced KW neighbourhoods with prayer, presence, and a desire for people to meet and follow Jesus.

The OHT now comprises of Trevor Seath, Brent Kipfer, Jeff Martens, Doug Valerio and we are bringing Natasha Baines from Manotick Community Church on the Team for 2025.

Report to the Ontario Conference of Mennonite Brethren Churches From the Board of Valleyview Manor

Date: February 10, 2025

Subject: Confirmation of Charitable Objects, Strategic Focus, and Partnership with ONMB

Dear Members of the Ontario Conference of Mennonite Brethren Churches,

On behalf of the Board of Valleyview Manor, we are writing to provide an update on our organization's focus, strategic direction, and relationship with the Ontario Conference of Mennonite Brethren Churches (ONMB). This report affirms our charitable objects, outlines key changes in our operational mandate, and clarifies our ongoing commitment to our partnership with ONMB.

Clarification of Charitable Objects and Strategic Focus:

As we move forward in fulfilling the mission of Valleyview Manor, our board has determined that Valleyview will focus exclusively on operating a Christian home for seniors of low or modest income. Considering this decision, we will work to amend our charitable objects to remove direct care services, such as medical or assisted care for residents. Rather, our focus will be on providing affordable accommodation in a Christian environment.

While we will not be providing care in the traditional sense, the board has received input from the Canadian Council of Christian Charities (CCCC) and has confirmed that Valleyview Manor will be able to continue operating as a charitable organization under the relief of poverty provision, as defined by the Canada Revenue Agency.

Governance and Release of Controlling Interest:

Our board also has determined that we are ready to request to be released from the controlling interest which the ONMB has exercised over Valleyview since its founding. We recognize and appreciate the support and oversight that ONMB has provided throughout the history of Valleyview, and we remain committed to our shared values and mission.

As we move towards this new phase, the Valleyview Board intends to maintain a partnership relationship with ONMB. We will continue to ensure that the governance of Valleyview includes a minimum number of directors from ONMB member churches, ensuring that the leadership of the organization remains connected to the broader Mennonite Brethren community.

Conclusion:

We are grateful for the ongoing partnership and support of ONMB as we adapt to meet the needs of our residents and community. We believe that these changes will position Valleyview Manor to better fulfill its charitable mandate and serve those who need affordable housing in a Christian environment.

We look forward to continuing our relationship with the Ontario Conference of Mennonite Brethren Churches as we move forward in this new chapter of service. Should you have any questions or need further clarification, please do not hesitate to contact us.

2025 NATIONAL DIRECTOR REPORT

One of the reasons I pursued this role was the growing sense that CCMBC was budding into a new season. For the last eight years we have been in a season of significant change, restructuring, and revisioning. At times it has been very painful, yet much of the change was necessary. By God's grace, we are emerging from this challenging season with hope and hunger for what God wants to do in and through our churches. Here are a few of the highlights and opportunities that are before us.

Highlights

- 1. We ended the year with a large donation that covered our potential deficit. God's grace and the faithful generosity of our churches and donors is such an encouragement.
- 2. Praise God for his continued faithfulness as we grow into our vision with a collaborative posture. The vision that we believe God is inviting us to pursue is: "To cultivate a community and culture of healthy disciple-making churches and ministries, faithfully joining Jesus in his mission." To me, this is a very compelling and challenging vision. It is compelling because it reflects the unique call that God has given us as participants in his great unfolding story of redemption. It is challenging because we have not had a robust plan in our church ministries that incorporates disciple-making as an expectation of what it means to be a follower of Jesus. I want to celebrate a very big step forward with our vision and collaborative efforts. We have streamlined our vision and collaborative efforts with two key documents that will lead us into the future. These two documents — Collective Impact Strategy (CI Strategy) and Member Organization Agreements (MOAs) - are making their way through the necessary procedural channels and will be presented to the constituency for final affirmation.
 - a. Collective Impact Strategy: Our leading vision is called the Collaborative Unified Strategic Plan (CUSP-approved 2021). This is very comprehensive document. The Executive Board asked that we summarize this document into

- one page that clearly and simply summarized the larger CUSP document. This summary is called the Collective Impact Strategy (CI Strategy). The CI Strategy has been well received and is the basis of our collaborative efforts between all our provinces and agencies.
- b. Collaboration and Member Organization
 Agreements (MOAs): The governance posture we have recently adopted is called the collaborative model. The intention of this model of leadership/governance is to fundamentally serve one another in mutual submission, humility, and respect, realizing that each brings much to the conversations. It is a way of leading that intentionally puts aside personal agendas in order to pay attention to Jesus' leadership of our denomination, churches, and agencies. The ways in which we want to collaborate are outlined in what we are calling Member Organization Agreements (MOAs).
- 3. The National Ministry Team (NMT) has discerned two key initiatives towards our vision. First, we would like to have prayer increasingly become a core aspect of our ministry/missional DNA. We have been encouraged by the week of prayer during January 5-11, 2025. Our theme for that week - and for the year — is "Pray First/Pray Always". We had roughly 100 participants from across our country come together daily to pray. The good news is that many felt we needed to continue praying for our churches, and so we established a weekly 30-minute online prayer time time on Tuesdays at 12 p.m. PST. Second, I believe that the only way we are going to cultivate healthy disciple-making churches and ministries is through disciple-making initiatives. We are all exploring and learning the principles of disciple-making with the goal of discipling others towards disciple-making.
- 4. A major project the Executive Board completed this year was the writing of a new Governance Manual that is congruent with our by-laws, CUSP, and Collaborative Model.

Opportunities

- 1. 2025 is the 500th anniversary of Anabaptism. This is the historical and theological stream from which Mennonite Brethren emerged. There is much to celebrate in our story. I also believe that there is much our theological framework has to offer our broken and violent culture. We will explore one of these themes at EQUIP in October at North Kildonan Church in Winnipeg (October 23-25) led by Ken Esau and our National Faith and Life Team. The theme is "The Gospel, Peacemaking, and the Kingdom: God's Peace in an Age of Conflict, Chaos, and Confusion."
- 2. It does feel as though we are moving into a season of unity building and vision development. I believe this will be the outflow of praying together. And as we grow a culture of prayer, I am hoping that we can increasingly be supporting, blessing, encouraging, and resourcing one another in a spirit of humility and generosity for the glory of God and for the wonderful vision he has entrusted to us. This kind of unity will be noticed (John 17) by a watching world. Please consider joining our national weekly prayer gathering every Tuesday at noon (PST). You can sign up through the CCMBC website link.

So Grateful

I am so grateful for wonderful colleagues and leaders in our denomination. I am grateful for Jason Krueger who held the interim National Director role for the first few months of 2024. I am thankful to serve alongside our Executive Board who serve faithfully, diligently, and with humility. The same is true of the National Ministry Team who serve our provincial conferences and agencies with integrity and diligence. The CCMBC staff has had a significant turn over this year and are blessed to have added Leanne Janzen, Michelle Madnunatu, Carina Gallardo and Linda Fox. We welcomed Connie Dyck as the new Executive Assistant replacing Kara Friesen who left us to pastor a church in Winnipeg. Carson completed a much-earned sabbatical from November 9, 2024 to February 10, 2025. We are grateful to Jon Isaak, the director of our archives, who retired at the end of the year. He provided 13 years of steady, diligent service to our CCMBC family.

I would close my brief report with Psalm 126:3: "The LORD has done great things for us, and we are filled with joy." May this continue to be our experience and our anticipation!

NATIONAL FAITH & LIFE DIRECTOR REPORT FOR 2025 PROVINCIAL CONVENTIONS

Mandate

According to the Collaborative Unified Strategic Plan (CUSP), we as a Conference exist "to cultivate a community and culture of healthy disciple-making churches and ministries, faithfully joining Jesus in his mission." The National Faith and Life Team (NFLT) exists to articulate and safeguard Mennonite Brethren theological convictions, produce theological and pastoral resources, and provide discernment and guidance on current issues. The National Faith and Life Team stewards the Confession of Faith on behalf of the Conference.

Activities in 2024

This has been a very full year for me, but I experienced it with much joy because of the excellent National Faith and Life Team members, CCMBC Staff, and those on the National Ministry Team and Executive Board. I'm thankful to be part of all of these teams of deeply committed men and women of godly character. They are an inspiration and encouragement to me each and every day. Over the course of 2024, we said good-by to Karen West (ONMB Provincial Rep), Rob Thiessen (BCMB Conference Minister), and Doug Heidebrecht (Multiply Rep). We were very thankful for these three faithful team members and wish them God's best in their new endeavors.

- Some of the NFLT highlights for 2024 include:
- We produced a monthly "Contending in Prayer" resource that revolved around encouraging different types of prayers throughout the year (viz., gratitude prayers; blessing prayers; confession prayers; etc.).
- We gave final approval to Article 3: Creation and Humanity (Explanatory Notes); Article 4: Sin and Evil (Explanatory Notes) and Article 6: Nature of the Church (Explanatory Notes; Living the Confession [FAQs]) as part of our Confession of Faith Resource Revision Project.
- We are in the final approval stage for Article 5: Salvation (Explanatory Notes); Article 7: Mission of the Church (Explanatory Notes), and Article 9: Lord's Supper (Explanatory Notes). These are presently on the <u>CCMBC website</u> inviting feedback.
- We gave final approval to our "Loving Well our Trans Neighbours, Friends, and Family" for

- distribution to our pastors and church leaders.
- We partnered with MB Seminary and BCMB to oversee the Pastors Credentialing Orientation May 28-30, 2024 at Columbia Bible College (Abbotsford) with about 70 participants. We agreed that in 2025, PCO would become a regional event alternating between west (BC/AB/SK) and east (MB/ON/QC) with shared planning and implementation from these provincial conferences.
- We made a decision to discontinue the publishing of new topics in our NFLT Pamphlet Series and evaluate our existing pamphlets for relevance and constituency demand.
- The NFLT spent some significant time deliberating how we should navigate our 1999 and 2006 discussions around women and church leadership roles. We are continuing to talk about this in light of the reality of significant differences and perspectives across our national family. We do hope that all of CCMBC's member organizations and local churches can encourage and facilitate leadership development for gifted women within their community.

Besides all of these more formal NFLT involvements, I enjoyed writing the **Q&R Corner** in the MB Herald Digest addressing such topics as Progressive Christianity (Feb); the Nature of Suffering in Hell (April); Burial or Cremation? (Aug); the Role of Israel Today (Oct); and Children Leaving the Faith (Dec). I also joined the Direction journal Editorial Council as CCMBC's representative. The Fall 2024 issue was dedicated to the publication of presentations from Equip 2023 so I revised my "Why Church?" presentation and had it published there. Whenever possible, I try to say yes to serve in local churches and this year, I had the opportunity to teach a "From the Garden to the Desert: Genesis to Deuteronomy" summer course and an Old Testament Survey Fall course. These made my life very full but were very eniovable.

While we celebrate all the highlights from 2024 (and thank God for so many answered prayers!), we continue to engage around the following items for 2025:

 Our CCMBC theme for 2025 is "Pray First! Pray Always!" so our monthly prayer column will have this new name. We will be working slowly

- through short phrases from the Lord's Prayer each month. We have invited some new writers from across the country to contribute to the column.
- We are actively planning and anticipating an excellent Equip 2025 conference from October 21-23 at NKMB Church, Winnipeg. Our theme is: "The Gospel, Peacemaking, and the Kingdom: God's Peace in an Age of Conflict, Chaos, and Confusion." More information here.
- We are working with MB Seminary and ONMB to host the PCO 2025: Getting to Know the Family! (May 6-8, 2025) at Behta Darya Community Church (Mississauga, ON). More information here.
- We continue to give significant effort to our Confession of Faith Resource Revision Project and hope to process new explanatory notes for Article 10: Discipleship; Article 11: Marriage, Singleness, and Family; Article 12: Society and State; and Article 13: Love and Nonresistance. (Articles 12 and 13 will be the special focus of Equip 2025.)
- We have been asked to work on other resources related to Medical Assistance in Dying (MAiD) and about divorce and remarriage—especially in reference to pastors/leaders. It was deemed wise to wait for the completion of the Explanatory Notes on Article 14: Sanctity of Life and Article 11: Marriage, Singleness, and Family before addressing these topics. It is hoped that resources will become available for churches and pastors later in 2025.

PCO Group 2024

My prayer is always that everything that I do and that we do together as a family would reflect faithfully the character and mission of King Jesus and God's Kingdom. As we live into God's Kingdom story of 2025, may we engage fully into the Lord's Prayer, calling out to God to bring his Kingdom to earth as it is in heaven—and participating in disciple-making as a dimension of the Kingdom work in the world. Blessings and Shalom in Jesus as you pray and serve in your family, church, and community!

With you, we are partnering with Ryan Jantzi, Ministry Director for the Ontario Conference (ONMB) to help equip pastors and lay people through our new Teaching Church in Ontario.



This new Teaching Church is exciting because it will impact both our pastors and our churches. "An increasing number of our pastors are beginning as a mid-career, mid-life shift. Existing life responsibilities mean most will never attend seminary in a traditional oncampus format. And yet, deep theological formation still matters! It's been exciting to see a number of our pastors learn together, within our evangelical Anabaptist MB framework, in ways that weren't previously accessible. I believe that the development of the Teaching Church Partnership will enable ONMB toward a more faithful and fruitful collective witness to Christ."

Further, "Many people scattered across our churches have never had the opportunity for theological formation at an academic level, for various reasons. The level of participation at the first Teaching Church Partnership offering at WMB Church indicates that there is a hunger for this. What a joy to see lay **people young and old learning alongside** some of our pastors who are studying for credit." One lifelong learning participant expressed thankfulness:

"I am so thankful to have the opportunity to take part in this workshop. Thank you for coming to Ontario. I look forward to the next one."

MB CHURCHES

With you, we are partnering with Connie Maier, Pastor of Outreach & Implementation at Glencairn MB Church in Kitchner ON, to equip her church and others across the country.

She extended the invitation because, "I am a huge fan of biblical/theological training for both staff and lay folks within our conference. I did my seminary part-time, while serving as a lay leader in the church and loved the experience. I would hope that others would see the value in this opportunity and I was happy to spread the word with our Glencairn family. Having this hosted locally was a huge bonus for our churches in Ontario."

MB STUDENTS With you, we are partnering with three new graduate students who are benefitting from having access to world-class theological training close to home.

Scott Roes, Associate Pastor at Mapleview Mennonite Church, a congregation with a 150 year history, spoke appreciatively about the fact the MB Seminary was offering a course close to home for him. "It means that I can participate in MB Seminary courses. I am a part time pastor and I also have a dairy farm and a family. It would not be possible for me to travel to be part of these courses. Also the fact that the seminary coursed are brought to local churches makes it even more appealing. There is always the option of taking online courses but being able to be in the same room as the professor and the other students is much more appealing."





Brad Sherk, Pastor of Discipleship at Waterloo MB Church, was asked about a highlight from the course, "Interpreting Scripture Today" that was taught by Dr. Mark Wessner. He replied, "My highlight was the personal connections made with my professor and with the other students. Since we were all pastors, we really bonded over working through the material of the course. Mark's videos that he made to give us feedback on our assignments were meaningful and helpful." Brad also expressed appreciation of being able to study close to home, allowing him to remain connected with his church family and saving time and resources.

Michael Reimer, youth ministry director at Cornerstone Community Church, shown here baptizing one of his youth, talked about his first seminary course being a rich experience because he was able to learn alongside people from his home church. He mentioned how meaningful it was "seeing how thoughtful and careful our approach is to seeing the depth of Scripture and understanding it well to apply it in our lives today." "The course has impacted my ministry by giving helpful language, methodology, and experience in diving DEEP into Scripture to let it have all the more impact and effect on how I carry myself as someone who wants to be deeply impacted by God and His word."





Camp Crossroads Update

Encouraging Trends

 1:1 mentoring meetings have been encouraging as many students dig deeper into their faith.

 There are 30+ students involved in our worship and tech ministry.

 Many students are being baptized in local churches and the SLC has been mentioned in several testimonies.

 We began a new Life Group that is focused on outreach.
 15-20 students are being introduced to Jesus through deep questions on faith and life.

 Our daily morning chapel hosts an average of 130 students each day morning.

The word "resound" has woven itself into the fabric of our ministry. It means to be "unmistakable and emphatic" and this is the faith we desire for high school students as they live in Christ. God is working powerfully at Eden and although we're excited by the metric of "numbers", it is the deep desire for authentic discipleship that is truly causing us to rejoice! Our mentoring connections are focusing on topics like baptism, how to be better in "sabbath", and deeper confession and repentance in students' personal walk with Jesus. Honestly, it is humbling to see such a clear vulnerability from teens who are passionate about sharing Christ with their friends, and living a genuine faith, even in difficult life situations.

Recently, we interviewed potential leaders for our leadership track Epereia, and we asked each to describe the spiritual burdens they have for their friends. One applicant replied, "I want my friends to know there's so much more beauty living a life for Christ than for yourself." This is the Holy Spirit at work in the lives of Eden teens as they long to see their friends experience the life and teaching of Jesus Christ!

Our first community worship night hosted 300 people in the Eden chapel.

Each fall, we host Grade Retreats at Camp Crossroads and they become instant highlights in the lives of those who attend! Following this year's retreats, a group of parents mentioned that they've always wanted to

experience a Grade Retreat, but have been unable to do so. From those conversations, we planned a worship night at Eden called "Becoming 2" (that was our retreat theme) and it was a powerful night where 300 grandparents, parents, alumni, and students showed up to sing and pray! The roof was lifted as we sang praise to God, calling out to our Heavenly Father as we knelt and prayed over the chapel space. Near the end of the evening, our students surrounded our parents and grandparents and prayed over them! There were many tears during this powerful expression of intercession and thankfulness! We are hosting



our second gathering, "Resound 2" on May 22 so if you can make it, you are welcome to attend!

In the midst of our joy, the Spiritual Life Centre continues to face many challenges as we minister within a public high school. Over the past two years, we have been negotiating a Community Partner Agreement with the school board. The purpose was to clarify and strengthen our position within Eden, while operating within the policies and procedures of the DSBN. It was a challenging process that required legal insight and many



meetings. An agreement was reached on May 30, 2024 and while it wasn't a perfect document, it afforded some encouragement. The challenge has been in the day to day "living out" of the document and that has brought significant hurdles, including limited access to our hallways and common areas. But God continues to be faithful! We are continuing to connect regularly with many students and are encouraged by the many that are accessing our SLC offices!

As I close, Ephesians 2:8-9 has been a powerful reminder that

God is making "masterpieces" from within our students and as He calls them to do those good works which He has prepared in advance, they are accepting the call! As we experience many Eden students surrendering to Jesus, we are watching Him hand-craft the hearts of prophets, poets, servants, peace-makers, reconcilers, ambassadors, and warriors. He is truly building His church within a generation that is not ashamed to live like Jesus!

The SLC ministry is situated in a public high school, providing one of the most unique opportunities to engage high school students with the life-changing Gospel of Jesus Christ. By God's grace, we are equipping a generation to go and bring Christ to their world. I continue to believe that this is a miraculous gift from God so please continue to pray for our team as we labour in Christ. On behalf of Meghan Plett who is in her 15th year,



MCC in Ontario


On January 18, 2025, over 700 people gathered at the MCC Hub in New Hamburg to celebrate the grand opening of the new MCC Meat Cannery. This 10,000-square-foot facility is set to make a significant impact on vulnerable communities worldwide with a goal of producing 60,000 cans of nutritious food annually for families in crisis. The event was filled with energy and hope as supporters, donors and volunteers celebrated alongside MCC staff, local elected officials and members of the local meat canning committees. With the new cannery, MCC is poised to provide even more vital food to families in need. Together, we can continue to make a lasting impact, one can at a time.



MCC Around the World

The war in Ukraine continues after three years and MCC partner, The Association of Mennonite Brethren Churches of Ukraine (AMBCU), continues to provide relief to people whose lives have been upended by the conflict. Each month they provide food packages to more than 200 families. Volunteers have distributed relief and hygiene supplies such as MCC relief kits, comforters and canned meat. They have also started responding to psychological needs, providing therapy and other supports to displaced children. Amid the darkness of violence and grief these churches are living out what it means to be a people of hope and clinging to the promise of advent that God is still with us and at work.

MDS Canada 2024: Restoring hope

"It is a tremendous thing to have this happen. To have a house built for you, it's beyond words," said Jade Shamen, one recipient of a volunteer-built home in North Shuswap, British Columbia.

Jade, his wife Isabelle and their four-year-old son Able were among hundreds of North Shuswap area residents affected by the Bush Creek East Wildfire in August 2023. The family was one of four households in the North Shuswap area to benefit from an MDS volunteer-built home this summer, while four more were helped with home repairs and renovations. Over a five-month period, 227 volunteers served in the North Shuswap.

Around the same time, a smaller national crew rebuilt a house in Lytton, British Columbia. Patsy Gessey and Owen Collings survived a wildfire in 2021. Due to several complicating factors — including toxic ash removal, loss of town records, archeological surveying requirements and updates to the local building code — rebuilding began more than two years after the fire flattened their village.

"I'm so grateful and thankful that I'm working with [MDS] because your organization shows hope... Some people have given up... but you've stuck with us," shared Owen.

Units were also active across the country with house builds taking place in Carstairs, Alberta, and Truro, Nova Scotia. Home repair projects were undertaken in Manitoba.

In Carstairs, more than 130 people volunteered to rebuild a house for Elisa Humphreys after she lost her home to a tornado last year. The house was built almost entirely by daily volunteers, 95 serving with MDS for the first time.

"God [directed] but people had to say yes. So, my heart was really warmed by how giving people were and what a great community we live in," said Jessica Lawrence, volunteer coordinator for the response.

In July, the Ontario Unit hosted the MDS Canada Family Project at Fraser Lake Camp near Bancroft, Ontario. Over four weeks, 48 people built three cabins and put the finishing touches on two more — to house camp volunteers and facilitate their program activities.

As I reflect on our work and relationships with disaster survivors and their communities in 2024, I am so grateful for the collective efforts of response coordinators, units, staff and the hundreds of daily, weekly and long-term volunteers who helped us achieve our mission to restore hope and homes. Thank you for your partnership in this work! I invite your continued prayers as we explore how to best serve our neighbours, across the country, in 2025.
